RE: 2017-RUI-100 - Ruling Final Outcome

In reference to rulings RETA2688, RETA2689, RETA2690, RETA2691, and SHRP5093 and in accordance with **16.47.1.8 (L)(1) (e) Reciprocity**, the **Trainer license** issued to **JUDD S. KEARL** shall remain suspended until he is reinstated by the **Texas Racing Commission**. Furthermore, **JUDD S. KEARL** must appear before the New Mexico Board of Stewards prior to any future licensing.

During said time of applicable suspension, **JUDD S. KEARL** is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, in accordance with **15.2.1.9 (C)(21) Exclusion**. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of, **JUDD S. KEARL** are ineligible to be entered or start in any race in this jurisdiction, per **15.2.1.9 (C)(21)(c) Exclusion**.

**Licensee is found to be in violation of and this ruling is written in accordance with:**

**16.47.1.8 (L)(1) (h) Reciprocity** The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has had a license denied, suspended, or revoked by any racing jurisdiction.

**16.47.1.8 (L)(1) (e) Reciprocity** The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has been found in violation of rules governing racing in this state or other jurisdictions

**16.47.1.8 (L)(1) (g) Reciprocity** The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has been or is currently excluded from association grounds by a recognized racing jurisdiction.

**15.2.1.9(C)(22)(a) Reciprocity** The stewards shall honor the rulings issued by other pari-mutuel racing commissions.

**15.2.1.9(C)(22)(b) Reciprocity** Appeals of reciprocal rulings. Persons subject to rulings in other jurisdictions shall have the right to request a hearing before the commission to show cause why such ruling should not be enforced in this jurisdiction. Any request for such hearing must clearly set forth in writing the reasons for the appeal.
