**Trainer Alfonso Borrego** having been duly notified telephonically and waived a hearing before the Board of Stewards on **July 20, 2018**, for failure to declare equipment (**Blinkers Off**) at time of entry for "**Mays O Mantle**", entered in the 19th race on May 18, 2018 at Downs at Albuquerque Racetrack.

Licensee is found to be in violation of:

15.2.5.8 (B)(10) Procedure For Entries Any approved change of equipment must be declared at time of entry. Any changes after that time must be approved by the stewards.

15.2.5.8 (B)(6) Procedure For Entries No alteration may be made in any entry after the closing of entries, but an error may be corrected with permission of the stewards

15.2.5.13 (A)(6) Equipment For The Running Of The Race: No licensee may add blinkers to a horse's equipment or discontinue their use without the prior approval of the starter, the paddock judge, and the stewards.

15.2.6.11(E)(10)Trainer Responsibility The trainer is responsible for ensuring proper bandages, equipment and shoes.

For this rule violation, the Board of Stewards assessed **Alfonso Borrego** a penalty in the amount of **one hundred dollars (\$ 100.00)**. The fine is to paid on or before **August 20, 2018** in accordance with 15.2.3.8(B)(3)(l) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension.

Action Type: Initial Ruling

Ruling:

Jockey, Jacquelyn A. Bobroff, is hereby summarily suspended (effective immediately, July 20, 2018) after having appeared before the Board of Stewards on July 20, 2018, for testing positive for methamphetamine (a prohibited substance) during a drug screening based upon reasonable suspicion, in order to ensure safety on the racetrack. Per 16.47.1.17 (A)(1)

During said time of applicable suspension Jacquelyn A. Bobroff is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC, per 15.2.1.9 (C)(21), pending the outcome of her hearing on July 29, 2018, at 9 am in the board of Stewards Office at the Downs of Albuquerque in accordance with 15.2.1.9 (B)(3)(b).

Licensee is found to be in violation of:

15.2.1.9(B)(3)(a): Which states in pertinent part "If the Stewards determine that a licensee's action constitute an immediate danger to the public health, safety, or welfare, the Stewards may summarily suspend the licensee pending a hearing".

16.47.1.16 (C)(7) Restricted Activities: It shall be an offense to exercise the privileges granted by a license from this commission if the licensee presently has drugs (controlled substances) or alcohol in his/her body. With regard to alcohol, the results of a test showing a reading of more than .05 percent of alcohol in the blood, urine, saliva or other bodily fluids of licensees in non-safety sensitive positions shall be the criterion for a finding of alcohol present in the body. With regard to other controlled substances, presence of the drug in any quantity measured by the testing instrument establishes the presence of the drug for purposes of this paragraph. Licensees in safety sensitive positions, jockeys, starters, assistant starters, exercise riders, pony persons, ambulance personnel, and outriders are in violation of this rule if they have any measurable level of alcohol.

16.47.1.8 (L)(1)(i) – Which states in pertinent part "The Commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures if the applicant is a person whose conduct or reputation may reflect on the honesty, and integrity of horse racing"

16.47.1.17 (A)(1) TESTING PROCEDURES At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the racetrack.

Licensee is found to be in violation of:

**15.2.5.12(A) HORSES INELIGIBLE:** A horse shall be ineligible to start in a race when it is not stabled on the grounds of the association or present by the time established by the commission.

**15.2.6.11(E)(10): Trainer Responsibility** ensuring that every horse entered to race is present at its assigned stall for a pre-race soundness inspection as prescribed in this part.

For this violation, the Board of Stewards assessed **Cynthia L. Longtin** a fine in the amount of **two hundred dollars (\$200.00)**. The fine is to be paid on or before **August 20, 2018** in accordance with 15.2.3.8 (B)(3)(8) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension
