RE: 2018-RUI-106 - Ruling Final Outcome

Pari Mutuel Employee, Amanda Brady, (summarily suspended on August 6, 2018) was duly notified and waived her rights to a 10-day notice and formal hearing before the Board of Stewards on August 6, 2018. The hearing was in regard to Amanda Brady testing positive for Marijuana (THC) during a drug screening on August 6, 2018.

The Board of Stewards hereby suspends all NMRC licenses belonging to <u>Amanda Brady</u> for <u>60 days</u>, <u>August 6, 2018, through October 4, 2018, inclusive</u> (retroactive from the summary suspension issued on <u>August 6, 2018</u>). 30 days will be deferred upon immediate enrollment in Chaplain Darrell Winter's Rehabilitation Program (16.47.1.18(C)). After 30 days has been served, <u>Amanda Brady</u> must submit a negative sample and is given probationary status. Furthermore, <u>Amanda Brady</u> may be tested at the request of the stewards at any time. Failure to attend "Chaplain Darrell Winter's Rehabilitation Program" will result <u>Amanda Brady</u> immediate suspension to serve the remainder of the 60 days.

During said time of applicable suspension <u>Amanda Brady</u> is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, in accordance with <u>15.2.1.9 (C)(21)</u>.
