RE: 2018-ZIA-24 - Ruling Final Outcome

Jockey Jaime Parga-Leos (summarily suspended on **September 30, 2018**) was duly notified and appeared for a disciplinary hearing before the Board of Stewards on **November 3, 2018**. The hearing was in regard to **Jaime Parga-Leos** testing positive for **cocaine** during a drug screening on **September 30, 2018**.

Midigating Circumstance: Jaime Parga-Leos presented proof of enrollment in the rehabilitation program of "Centro Familiar Cristiano".

The Board of Stewards hereby suspends all NMRC licenses belonging to **Jaime Parga-Leos** for **60 days, September 30, 2018, through November 28, 2018, 2018, inclusive (retroactive from the summary suspension date and 27 days has been deferred per continued attendance in the rehabilitation program of "Centro Familiar Cristiano" 16.47.1.18(C).)**

Jaime Parga-Leos has served 33 days of the suspension and is hereby restored to good standing and given probationary status. Furthermore, Jaime Parga-Leos has agreed to be tested at the request of the stewards at any time and must provide the Board of Stewards with weekly proof of attendance in the rehabilitation program of "Centro Familiar Cristiano". Failure to attend "Centro Familiar Cristiano" will result in Jaime Parga-Leos serving the remainder of the 27 day suspension.
