Jockey, JOHNNY MALDONADO, was summarily suspended on December 31, 2017, and waived his rights to a formal disciplinary hearing before the Board of Stewards on January 13, 2018. JOHNNY MALDONADO tested positive for marijuana metabolites during a drug screening on December 19, 2017.

The Board of Stewards hereby lift the summary suspension instated on **December 31, 2017**, and rescind the Jockey's license issued to JOHNNY MALDONADO, as he is no longer working in that capacity. Furthermore, JOHNNY MALDONADO must pass a drug test prior to any further licensing.

JOSE ASCENCION LOMELI tested positive for cocaine metabolites during a drug screening on December 29, 2017.

The Board of Stewards hereby issue **JOSE ASCENCION LOMELI** penalty of the following:

1. Suspension of all NMRC licenses for <u>60 days</u> (retroactive from the summary suspension instated on <u>December 31, 2017</u>) <u>December 31, 2017 through March 1, 2018, inclusive</u>.

Per 15.2.1.9 (C)(21)(a-b) NMAC, JOSE ASCENCION LOMELI is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC and all horses owned or under the care of by JOSE ASCENCION LOMELI are denied further entry.
