For this rule violation, the Board of Stewards assessed a penalty in the amount of two hundred dollars (\$ 200.00). The fine is to paid on or before October 22, 2017, in accordance with 15.2.3.8(B)(3)(1) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension.

### Licensee is found to be in violation of:

15.2.5.8(B) (7) No horse may be entered in more than one race (with the exception of stakes races) to be run on the same day at the same track on which pari-mutuel wagering is conducted. If a horse is entered in more than one stakes race to be run on the same day, at the time of draw, the trainer must declare which race the horse will run in.
