R. License presentation:

(1) A person must present an appropriate license or other authorization issued by the commission to enter a restricted area. The commission may issue authorization to the spouse or child of a licensed owner, trainer or jockey to enter a restricted area. (2) The stewards may require visible display of a license while the licensee is engaged in the duty for which he/she is licensed and on the association grounds unless the licensee is mounted on a horse. (3) A license may only be used by the person to whom it is issued.

S. Temporary access authority:

Track security may authorize unlicensed persons temporary access to restricted areas. Such person shall be identified and their purpose and credentials verified and approved in writing by track security. Such authorization or credential may only be used by the person to whom it is issued. T. Knowledge of rules: A licensee shall be knowledgeable of the rules of the commission;

Jockey Omar Iturralde, having been summoned and having appeared before the Board of Stewards on September 14, 2018 for failure to make sufficient effort to maintain his lane while aboard "Flash of Victory" in the 4th race on September 13,2018 at The Downs at Albuquerque Racetrack.

Licensee is found to be in violation of:

15.2.5.13(E)(3)(d) NMAC: Post to Finish (d) In a straightaway race, every horse must maintain position as nearly as possible in the lane in which it starts. If a horse is ridden, drifts or swerves out of its lane in such a manner that it interferes with, impedes or intimidates another horse, it is a foul and may result in the disqualification of the offending horse.

The Board of Stewards hereby assessed, **Omar Iturralde**, a fine in the amount of **two hundred dollars**, (\$200.00). The fine is to be paid on or before **October 14**, 2018, in accordance with 15.2.3.8 (B)(3)(l). Failure to pay the fine within the time prescribed will result in immediate suspension.

Trainer, Arnoldo Carrillo, is hereby summarily suspended (effective immediately, September 14, 2018 for the detection of the Class B drug Clenbuterol in sample #E277054, per 15.2.1.9(B)(2).

The summary suspension is in regard to a certificate of analysis from **Industrial Laboratories (official testing laboratory for the NMRC)** for a confirmed positive for the (class 3 penalty B) drug "Clenbuterol" in horse "Coronas Dashin Injun" (Test Sample #: E277054) who finished SECOND place in the 4th race on August 26, 2018, at The Downs in Albuquerque, NM.

15.2.6.9(C)(4) There is no permissible concentration of Clenbuterol that is allowed to appear in any official sample.

In accordance with 15.2.1.9 (C)(21), Arnoldo Carrillo is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC and all horses owned, trained, or under the care Arnoldo Carrillo are denied entry, pending the outcome of his hearing on September 20, at 9:30 am in the Board of Steward's office at The Downs at Albuquerque Racetrack, per 15.2.1.9 (B)(3)(b).

Licensee is found in violation of:

15.2.6.9(C)(4) There is no permissible concentration of Clenbuterol that is allowed to appear in any official sample.

16.47.1.8 (U)(1) PROTECTION OF HORSES Each person licensed by the commission shall do all that is reasonable and within their power and scope of duty to guard against and prevent the administration of any drug, medication or other substance, including permissible medication in excess of the maximum allowable level, to any horse entered or to be entered in an official workout or race, as prohibited by these rules.

This ruling is written in accordance:

15.2.1.9(B)(3)(a) NMAC: Which states in pertinent part "If the Stewards determine that a licensee's action constitute an immediate danger to the public health, safety, or welfare, the Stewards may summarily suspend the licensee pending a hearing".

15.2.6.9 (A)(11) NMAC: Any person who the stewards or the commission believe may have committed acts in violation of criminal statues may be referred to the appropriate law enforcement agency. Administrative action taken by the stewards or the commission does not prohibit a prosecution for a criminal act, nor does a potential criminal prosecution stall administrative action by the stewards or the commission.

A positive test for a prohibited drug or medication or other prohibited substance or the presence of permitted medication in excess of maximum allowable levels as reported by the commission approved laboratory is prima facie evidence of a violation of this rule. The Trainer is absolutely responsible regardless of the acts of third party."

Jockey, Jacquelyn Bobroff having appeared before the Board of Stewards on September 14, 2018, testing positive for prohibited substances Methamphetamine.

Licensee is found to be in violation of and This Ruling is written in accordance with

6.47.1.17 (A)(1) TESTING PROCEDURES At its discretion, the commission may conduct random or episodic random drug testing, as well as testing based on reasonable suspicion, in order to ensure safety on the racetrack.

16.47.1.16 (C)(7) Restricted Activities: It shall be an offense to exercise the privileges granted by a license from this commission if the licensee presently has drugs (controlled substances) or alcohol in his/her body. With regard to alcohol, the results of a test showing a reading of more than .05 percent of alcohol in the blood, urine, saliva or other bodily fluids of licensees in non-safety sensitive positions shall be the criterion for a finding of alcohol present in the body. With regard to other controlled substances, presence of the drug in any quantity measured by the testing instrument establishes the presence of the drug for purposes of this paragraph. Licensees in safety sensitive positions, jockeys, starters, assistant starters, exercise riders, pony persons, ambulance personnel, and outriders are in violation of this rule if they have any measurable level of alcohol.

16.47.1.8 (L)(1)(i) - Which states in pertinent part "The Commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures if the applicant is a person whose conduct or reputation may reflect on the honesty, and integrity of horse racing" 16.47.1.18 (C) ASSESSMENT/TREATMENT REQUIREMENTS GENERAL SECOND-TIME OFFENDERS: (1) The license of the person may be revoked or suspended for a period of up to one year or a professional assessment of the person may be ordered by the commission. (2) If a professional assessment indicates presence of a problem or alcohol or other drug abuse that is not treatable within the reasonably foreseeable future (360 days) the license may be suspended for a period of up to one year. (3) If a professional assessment indicates presence of a treatable problem of alcohol or other drug abuse or dependence, the board of stewards or the commission may order the licensee to undergo treatment as a condition of continuing licensure. Such treatment will be through a program or by a practitioner, acceptable to the licensee and the board of stewards or the commission. Required features of any program or practitioner acceptable to the board of stewards or the commission will be: accreditation or licensure by an appropriate government agency, if required by state statute; a minimum of one year follow-up treatment; and, a formal contract indicating the elements of the treatment and follow-up program that will be completed by the licensee and, upon completion, certified to the board of stewards or the commission as completed. To effect the contract, the licensee will authorize release of information by the treating agency, hospital or individual.

For this violation, the Board of Stewards issue Jacquelyn Bobroff a penalty of the following:

- 1. Suspension of all NMRC licenses for 90 days retroactive September 14, 2018 through, December 13, 2018 inclusive.
- 2. In Addition Jacquelyn Bobroff must complete a formal assessment and treatment that must meet the conditions given in 16.47.1.18.C NMAC prior to reinstatement.

During said time of suspension Jacquelyn Bobroff is denied access to all grounds under the jurisdiction of the New Mexico Racing Commission in accordance with 15.2.1.9(C)(21)(a) NMAC.
