The NMHA Bylaws direct them to actively promote the sport of horse racing in NM, to represent the horsemen's racing interests, property rights and to work for the improvement of working and/or living conditions for backside personnel. The condition of Zia Park race track surface as well as the working conditions on the backside, to include but not limited to, the availability of water, exercise/training schedule and protocols at best do not address industry standards for "best practices" are substandard and may be dangerous to both the horsemen and the equine athletes. This statement is supported by 68 signatures of horsemen currently holding licenses and working on the backside of Zia Park. From the time the horsemen were allowed on the grounds and the set up stalls, Mr. Erhard said he began receiving multiple calls with complaints regarding the conditions of the barn area. Once the track opened for training and exercise, he began receiving complaints of the racing surface. He observed that the track was not prepared for the meet and confirmed the complaints by the horsemen. NMHA respectfully requests that the NMRC investigate these issues (past and present similar concerns) of Zia Park's as soon as possible. Chairwoman Bourguet asked that Mr. Erhard to send the script that he just read from to the Commissioners.
