(drifed into the path of the 4, causing the 4 horse to clip heels and unseat its rider.)

The Board of Stewards hereby assess <u>J C Villanueva</u> a suspension of <u>3 race days (August 18,19,20, 2017) J C Villanueva</u> is allowed to ride designated races.

DVM Joe Cooke having been duly notified and having appeared with attorney Gary C. Mitchell before the Board of Stewards on August 11, 2017, concerning a hearing that was continued at the request of Gary C. Mitchell from July 27, 2017. The hearing was in regard to an affidavit from UC Davis (official testing laboratory for the NMSRC) for the confirmed positive for the drug "Xylazine" (drug class 3, penalty B) detected in the blood of horse "Tizpat" (Test Sample NM23753), who finished 1st place in the 8th race on January, 31, 2017, at Sunland Park Racetrack in Sunland Park, NM.

Mitigating Circumstances: Dr. Cooke has had no previous violations.

Aggravating circumstances:

- 1. Test Sample NM23753 was confirmed positive by UC Davis for the drug "Xylazine" at a level of 800 pg/ml, which was above the allowable limit of 200 pg/ml.
- 2. Dr. Cooke testified that he did administer a shot four hours prior to post time to the horse "Tizpat".
- 3. Dr. Cooke testified that veterinarian technicians pre-draw syringes prior to the start of that day.
- 4. Dr. Cooke testified that he could not recall the name of the technician that drew up the syringes on that day.
- 5. Dr. Cooke testified that he did not know the exact amount of liquid in the syringe that he administered to "Tizpat" four hours prior to the race.
- 6. Test Sample NM23753 was tested for the drug "furosemide /lasix" by UC Davis and failed to confirm the present of the drug "furosemide /lasix".
- 7. Dr. Clements testified that Xylazine is a fast acting drug that lasts up to 1.5 to 4 hours.

After considering the aggravating circumstances, the Board of Stewards assess Joe Cooke a fine in the amount of five hundred dollars (\$500) and is ordered to make restitution for the loss of purse money to owner Fred Danley in the amount of six thousand three hundred and sixty dollars (\$6,360). The fine and restitution is to be paid on or before September 12, 2017, in accordance with 15.2.3.8 (B)(3)(l) NMAC. Failure to pay the **fine and restitution** within the time prescribed may result in immediate suspension.
