Jockey <u>Jose Amador Alvarez</u> having been duly notified <u>and having appeared</u> before the Board of Stewards on <u>July 9, 2017</u>, for his excessive use of the whip on his mount <u>"CALL ME COLE"</u> during the running of the <u>2nd race on July 8, 2017, at Ruidoso Downs.</u>

The Board of Stewards assess <u>Jose Amador Alvarez</u> a penalty in the amount of <u>two hundred</u> <u>dollars (\$200.00)</u>. The fine is to be paid on or before <u>August 9, 2017</u>, in accordance with 15.2.3.8 (B)(3)(l). Failure to pay the fine within the time prescribed may result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.

Pony Person <u>Miranda Arreola</u>, appeared before the Board of Stewards on <u>July 13, 2017</u>, for a hearing concerning a summary suspension issued on <u>July 8, 2017</u>, for being in possession of injectable items at Ruidoso Downs (<u>refer to ruling 2017-RUI-74</u>) to determine whether licensee should remain suspended pending a final disciplinary hearing and ruling.

After hearing testimony and examining the evidence presented, the Board of Stewards lifted the summary suspension and credited Mrs. Arreola with time served. <u>In addition, after waiving her right to a 10 day notice and formal hearing, Miranda Arreola is hereby fined an amount of \$500 (five hundred dollars)</u>. The fine is to paid on or before <u>August 13, 2017</u>, in accordance with 15.2.3.8(B)(3)(l) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension

Licensee is found to be in violation of:

Trainer Jaime Aldavaz having been duly notified and appeared with translator Maggie Aldavaz before the Board of Stewards on July 15, 2017, regarding a lab report from UC/Davis (official testing laboratory for the NMSRC), for a confirmed positive for the prohibited Class 3B stanozolol metabolite "16 hydroxy-stanozolol" detected "A Fancy La Jolla" (test sample #NM23852), who finished 2nd place in the 7th race, on February 10, 2017, at Sunland Park Racetrack in Sunland Park, NM. "16 hydroxy-stanozolol" was confirmed in the split sample sent to Texas A&M.

The Estate of Currie Maben, the owner of record for the horse "A Fancy La Jolla", was duly notified and represented by Nadine Maben for the hearing. This is The Estate of Currie Maben's FIRST Class 3B medication violation in a LIFETIME, issued in accordance with 15.2.6.9.(B)(2) Penalty recommendations.

MIDIGATING CIRCUMSTANCES: trainer has had no medication violations since June of 2015. <u>AGGRIVATING CIRCUMSTANCES</u>: the stanozolol metabolite "16 hydroxy-stanozolol" is prohibited in out of competition testing and/or post race, per rule 15.2.6.9(G)(1)(3)

ANDROGENIC-ANABOLIC STEROIDS, unless prescribed by a veterinarian pursuant to rule 15.2.6.9(C)(11) Procedure For Prescribing Medication. <u>Jaime Aldavaz</u> failed to follow proper procedures for the use of Stanozolol.

After considering the mitigating and aggravating circumstances, for Jaime Aldavaz's THIRD Class 3B medication violation in a LIFETIME, the Board of Stewards assessed a penalty in accordance with 15.2.6.9.(B)(2)Penalty recommendations as follows.

- 1. A <u>6 month</u> suspension of all NMRC licenses starting July 26, 2017, through January 25, 2018 inclusive.
- 2. 2. (\$2,500) two thousand and five hundred dollar fine to paid on or before August 16, 2017, in accordance with 15.2.1.9(B)(7)(f) NMAC and 15.2.3.8 (B)(3)(l) NMAC: Failure to pay fine in prescribed time may result in an immediate suspension.

During said time of applicable suspension, Jaime Aldavaz is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC, in accordance with 15.2.1.9 (C)(21)(a-b) NMAC, and 15.2.3.8 (B)(3)(f) NMAC. For The Estate of Curric Maben's FIRST Class 3B medication violation in a LIFETIME, the Board of Stewards assessed a penalty in accordance with 15.2.6.9.(B)(2)Penalty recommendations as follows.
