the <u>Board of Stewards at Ruidoso Downs (26225 US-70, Ruidoso NM 88346)</u>, per <u>15.2.1.9 (B)(3)</u>
(b) <u>Summary Suspension</u>. <u>Jose Luis Enriquez</u> is hereby excluded from all areas of the grounds
under the jurisdiction of the NMRC, per 15.2.1.9 (C)(21).
