The hearing was in regard to a certificate of analysis from UC Davis (official testing laboratory for the NMRC) for a confirmed positive for the prohibited (class 3 penalty B) drug "clenbuterol" detected in the urine of horse "Royal Speed" (Test Sample #: NM33148), who finished 2nd place in the 2nd race on June 8, 2018, at Ruidoso Downs in Ruidoso, NM. Split sample rights as provided in 15.2.6.10 (D), were afforded to Juan R. Meraz. However, horse "Royal Speed" failed to provide a sufficient amount of sample (which is required for the split sample), in accordance with 15.2.6.10 (B)(3)Sample Collection and 15.2.6.9(C)(1) Prima Facie Evidence the entire specimen was sent to UC DAVIS.

Abelardo Chavez, the owner of record for horse "Royal Speed", was duly notified and failed to appear for this hearing. This is Abelardo Chavez's FIRST Class 3B medication violation in a 365-day period.

For Juan R. Meraz's SECOND Class 3B medication violation in a 365-day period, the Board of Stewards hereby assess a penalty, issued in accordance with 15.2.6.9 (B)(2) Penalty Recommendations, as follows:

- 1. A 90 day suspension of all NMRC licenses starting July 31, 2018, through October 28, 2018, inclusive.
