Jockey **J R Ramirez** was summoned and appeared before the Board of Stewards **on August 31, 2019**, for careless riding during the running of the **3rd race on August 30, 2019 at Ruidoso Downs**, while **aboard "Kiss My Whuut", which resulted in his mount being disqualified from 3rd place to 7th place. (Bore out late into the path of #6 causing him to check sharply.)**

The Board of Stewards hereby assess **J R Ramirez** a suspension of **7 calendar days (September 7, 2019, through September 13, 2019, inclusive)**. The term of this suspension shall not prohibit participation in designated race days.

Jockey Mauro Salcedo, was duly notified, and appeared before the Board of Stewards on August 31, 2019. The hearing was in regard to Mauro Salcedo's misuse of whip on his mount "R Scootin On" during the post parade for the 4th race on August 30, 2019, at Ruidoso Downs.

The Board of Stewards hereby fines Mauro Salcedo in the amount of two hundred dollars (\$200.00). The fine is to be paid on or before September 30, 2019, in accordance with 15.2.3.8(B)(3)(I) NMAC. Failure to pay the fine within the time prescribed will result in immediate suspension.
