		 Chairwoman Bourguet discussed a letter to the Governor signed by 4 of the 5 racetracks regarding consideration to open racetrack casinos in a limited capacity. The letter was signed by Zia Park, Sunland Park, Ruidoso Downs, and SunRay Park managers. There has been a request by track management and others regarding ADWs – we need to look at statutes to allow New Mexicans to wager on NM tracks while they are not on a licensed track. In order to get this bill passed, collaboration needs to happen between all racing entities. NM is behind the curve when it comes to ADW. Regarding the Horse Racing Integrity and Safety Act of 2020; We are waiting to see how this will impact all of the states and the horse racing industry. The NM Racing Industry needs to decide whether we want to opt out or partake in this for QHs. There is no choice for our TBs. Chairwoman Bourguet went over some of the particulars about this Act. "The Authority" (Federal Trade Commission) which is an Independent, self-regulatory entity

They will have a mandated study on LASIX but this procedure will soon be phased out. Commissioner Buffington discussed waiting for clarity (which not much more has been given) and now we are out of time. He has reached out to the horsemen group and track management with proposed dates. He has received the tracks' preliminary information. He understands that the horsemen's group met yesterday so Commissioner Buffington has not had a chance to follow-up to get their proposals. In overnight races, the NMHBA contributed \$358,000. This is \$92,000 more than contributed last year. They averaged 3.28 NM Bred per day, +5 for three a day; 59% TB and 41% QH.	
	39:35 – 42:29	Tom Goncharoff, President of NMHBA addressed the Commissioners Zia Park's Training Schedule. This request is coming directly from TB Trainers. It is their understanding that Zia Park will be available for 5 days a week of training. They are requesting the assistance from the Commissioners to help require Zia Park to make training available at least 6 days a week. Mr. Goncharoff was also asked to find out what is common, nationally, for training days of TB horses. Richard Mandella of California was surprised that Zia Park would only be open for training and was told that it is customary for tracks to be open 7 days a week for training. Mr. Goncharoff also spoke with Shug McGaughey and he had a similar response. The biggest concern from the trainers is a safety issue. There is a chance of injury with the lack of exercise.
