Trainer Ivan Tafoya, responded via telephone, **and waived his right to a 10 day notice and formal hearing** before the Board of Stewards on **May 4, 2019**. The hearing was in regard to **Ivan Tafoya** failing to declare equipment (**Flipping Halter off**) at time of entry for **“One Famous Gal”**, entered in **the 5th race on May 3, 2019, at Sunray Park Racetrack.**

The Board of Stewards hereby fines **Ivan Tafoya** in the amount of **Two Hundred Dollars (\$ 200.00)**. The fine is to paid on or before **June 3, 2019** in accordance with 15.2.3.8(B)(3)(I) NMAC. Failure to pay the fine within the time prescribed shall result in immediate suspension.
