Clenbuterol was confirmed in the split sample sent to Industrial Laborites on January 17, 2017. Victor Diaz, owner of record for horse "Fishin For Dough", was duly notified and failed to appear for this hearing. In accordance with rules 15.2.6.9 (C)(2)(b) and 15.2.1.9(B)(4)(d), this is Mr. Diaz's FIRST Class 3B medication violation in a 365-day period. For this FIRST Class 3B medication violation in a 365-day period issued in accordance with 15.2.6.9 (L) NMAC, the Board of Stewards assessed Martin Orona Jr a penalty as follows.

1. A 15 day suspension of all NMRC licenses starting January 28, 2017, through February 12, 2017, inclusive.
