<u>Jockey Jaime Parga Leos</u> having been duly notified and having appeared before the Board of Stewards on <u>December 31, 2017</u>, for his excessive use of the whip on his mount <u>"IGOTGAME RF"</u> during the running of the <u>9th race on December 22, 2017</u>, at <u>Sunland Park Racetrack</u>.

The Board of Stewards fine <u>Jaime Parga Leos</u> in the amount of <u>two hundred dollars (\$200.00)</u>. The fine is to be paid on or before <u>January 31, 2018</u>, in accordance with 15.2.3.8 (B)(3)(I). Failure to pay the fine within the time prescribed may result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.

Jockey <u>Jaime Parga Leos</u>, having been summoned <u>and having appeared</u> before the Board of Stewards <u>December 31, 2017</u>, for careless riding during the running of the <u>3rd race on December 29</u>, 2017, at <u>Sunland Park Racetrack</u>, while <u>aboard "FIRST STOLIS BLOOD"</u>.

For this violation, the Board of Stewards assessed <u>Jaime Parga Leos</u>, a suspension of <u>7 calendar</u> <u>days (January 9, 2018, through January 15, 2018)</u>. <u>Jaime Parga Leos</u> is allowed to ride designated races.

Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."
