Trainer/Owner Gerald E. Marr was duly notified and appeared for a hearing before the Board of Stewards February 9, 2018. The hearing was in regard to an affidavit from UC/Davis (official testing laboratory for the NMRC) for a confirmed positive for the prohibited drug "D-Methamphetamine" detected in horse "Alpha Doll "(Test Sample NM27919), who finished 1st place in the 10th race on August 27, 2017, at Ruidoso Downs Racetrack. D-Methamphetamine was confirmed in the Split Sample by Industrial Laboratories on November 8, 2017.

AGGRAVATING CIRCUMSTANCES:

- As the trainer, Gerald Marr, is responsible to guard and protect his horses from the acts of third parties, per 16.47.1.10(B)(1).
- The horse, "Alpha Doll", was trained by and in the care and custody of trainer Gerald Marr.
- The horse "Alpha Doll" did participate in the 10th race on August 27, 2017, at Ruidoso Downs Racetrack and placed first with a prohibited substance in her system.

MITIGATING CIRCUMSTANCES:

- Gerald E. Marr, a licensed trainer for approximately 50 years, has no prior major medication violations.
- More likely than not, human contamination was a factor.

After considering the aggravating and mitigating circumstances, the Board of Stewards hereby issue Gerald E. Marr a penalty as follows.

1. A (\$2,500.00) two thousand five hundred dollar fine to paid on or before March 11, 2018, in accordance with 15.2.3.8 (B)(3)(I) NMAC: Failure to pay fine in prescribed time may result in an immediate suspension.

2. Pursuant to rules 15.2.3.8(B)(9)(a)(e), 15.2.6.9(C)(7)(a), 15.2.6.9(C)(8)(a), 15.2.6.9(C)(9)(10), the horse "Alpha Doll" is placed on the Stewards list for a period of 60 days (beginning September 12, 2017). During this period, the papers are to be removed from the racing office and horse is denied entry until it passes a commission approved veterinary examination with a negative blood and urine

3. The horse "Alpha Doll" is hereby disqualified from FIRST Place and ordered unplaced from the 10th race on August 27, 2017, at Ruidoso Downs Racetrack, for all but pari-mutuel wagering. The purse redistribution is as follows.

- 1) Royal Cha Cha
- 2) Kit Paranod
- 3) Winter Home
- 4) Miss Domesius
- 5) Hottothetouch

<u>Carlos Ortiz</u>, the <u>owner</u> of record for horse "<u>Charlies Soldier</u>", was duly notified and appeared for this hearing. This is <u>Carlos Ortiz's SECOND Class 3B medication violation in a lifetime.</u>

For Esteban Ramirez's FIRST Class 3B medication violation in a lifetime, the Board of Stewards assessed a penalty issued in accordance with 15.2.6.9 (B)(2) Penalty Recommendations as follows:

The affidavit was for a confirmed positive for the therapeutic drug, Phenylbutazone (class 4 penalty category C MINOR drug) found in test sample NM 28626 taken from the winner "Big Woody Cartel" following the 5th race, on January 19, 2018, at Sunland Park Racetrack in Sunland Park, NM.

The original lab report indicated a finding of Phenylbutazone at 4.02 micrograms per milliliter in the blood, which exceeds the allowable limit of 2.0 micrograms per milliliter in the blood. Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to and declined by Emmanuel Galvez. Sherri Galvez, the owner of record for horse "Big Woody Cartel", was telephonically notified that her trainer waived his rights to a formal hearing on February 23, 2018. This is Sherri Galvez's FIRST Class 4C MINOR medication violation in a 365-day period.

For Emmanuel Galvez's FIRST Class 4C MINOR medication violation in a 365-day period, the Board of Stewards hereby assess a (\$300) three hundred dollar fine to be paid on or before March 26, 2018, in accordance with 15.2.3.8 (B)(3)(1) NMAC.
