Trainer: **Salvador R. Soto**, having been duly notified and appeared before the **Board Of Stewards on April 6, 2019, regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC)**, for a confirmed positive for the drug, **Dexamethasone** (class 4C-Major penalty drug) found in test sample **E291784** taken from the **1st place finisher "Tictoctee"** following **the 2nd race, on January 25, 2019, at Sunland Park Race Track.**

The original lab report indicated a finding of **Dexamethasone at 16.3 +/- 2.2 pg/ml in the blood**, exceeding the allowable limit of 5 pg/ml in the blood (**15.2.6.9 Attachment 2**). Split sample rights as provided in **15.2.6.10 (D) NMAC**, were afforded to the trainer, and declined.

Yvonne Ramirez is the owner of record for horse "**Tictoctee**"

This is **Salvador R. Soto's Second Class 4C-Major medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4)**. The Board of Stewards assessed a penalty as follows:
