The original lab report indicated a finding of Ketoprofen at 121 ng/ml +/- .2 ng/ml in the blood, the allowable limit for Ketoprofen is 50ng/ml in the blood for a 4-C Major (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer, and declined.

Aggravating factor: "Ostarine" has no therapeutic use in racehorses, and is generally administered to improve performance and affect the outcome of a race.

Aggravating factor: Eighth 1-A drug violation in 2019

Aggravating factor: per 15.2.6.9 (A)(4) NMAC: Any drug or metabolite thereof found to be presenting a pre- or post-race sample which is not classified in the association of racing commissioners international uniform classification guidelines for foreign substances shall be assumed to be an association of racing commissioners international class 1 drug and the trainer and owner shall be subject to those penalties as set forth in penalty category A unless satisfactorily demonstrated otherwise by the racing medication and testing consortium, with a penalty category assigned.

Note: Neither witnesses nor evidence was presented to disprove the findings of the New Mexico Racing Commission.

For Bobby R. Martinez's Eighth Class 1A medication violation in a LIFETIME, the Board of Stewards hereby assess a penalty, issued in accordance with 15.2.6.9 (B)(1) Penalty Recommendations, as follows:

- 1. Revocation of any NMRC licenses and is ineligible to apply for any NMRC licenses until July 13, 2054 These dates consecutively follow another ineligibility period. Per 15.2.6.9 (B)(5) NMAC, should any dates be revised, this ineligibility shall move up or start immediately.
- 2. A (70,000.00) Seventy thousand dollar fine to paid on or before April 30, 2020, in accordance with 15.2.3.8 (B)(3)(k). Failure to pay the fine in the prescribed time shall result in an immediate suspension in accordance with 15.2.1.9 C(21).
