The State Investigator changed to include the name "Ryan".

Owner/Trainer Martin Orona Jr. was duly notified and represented by attorney Daniel Marquez before the Board of Stewards on March 10, 2018, for a hearing that was continued at the request of Daniel Marquez from January 14, 2018, to January 28, 2018, and then continued again to March 10, 2018. The hearing was in regard to an affidavit from UC/Davis (official testing laboratory for the NMRC) for a confirmed positive for the class 3 penalty B drug stanozolol metabolite "OH-stanozolol" detected in the urine of horse "Johnny Walker" (Test Sample #: NM12865), who finished FIRST place in the 2nd race on June 5, 2015, at Ruidoso Downs Racetrack in Ruidoso, NM.

<u>Rogelio Carrasco Sr.</u>, the <u>owner</u> of horse "<u>Johnny Walker</u>", was duly notified and failed to appear for this hearing.

The Board of Stewards hereby dismisses this case due to lack of evidence presented by State Investigator Ryan during the hearing. The case is hereby dismissed and the purse being held from the 2nd race on June 5, 2015, at Ruidoso Downs Racetrack shall be released in its original order.

Jockey, Damian Corral, was summarily suspended on March 13, 2018, and waived his rights to a formal disciplinary hearing before the Board of Stewards on March 20, 2018. Damian Corral tested positive for Marijuana (THC) during a drug screening on March 13, 2018.

The Board of Stewards hereby suspends all NMRC licenses belonging to **Damian Corral** for **60 days**, March 13, 2018, through May 11, 2018, inclusive (retroactive from the summary suspension issued on March 13, 2018). 30 days will be deferred upon immediate enrollment in Chaplain Donald Stover's "Turning Point Program" (16.47.1.18(C)). After 30 days has been served, Damian Corral must submit a negative sample and is given probationary status. Furthermore, Damian Corral may be tested at the request of the stewards at any time. Failure to attend "The Turning Point Program" will result Damian Corral's immediate suspension to serve the remainder of the 60 days.

Per 15.2.1.9 (C)(21)(a-b) NMAC, While under suspension, Damian Corral is excluded from all areas of the grounds under the jurisdiction of the NMRC.

Owner Jesus Alvarez (currently under summary suspension) was duly notified, failed to appear, and had his hearing held in absentia, in accordance with 15,2.1.9(B)(4)(d)non-appearance, before the Board of Stewards on March 17, 2018. The hearing was in regard to Jesus Alvarez misrepresenting the horse "Tarzan On Fire" when the horse was brought through the Sunland Park Stable Gate on February 24, 2018, and presented as another horse on the health certificate. ("Tarzan On Fire" did not have a current health certificate).

The Board of Stewards hereby assess Rene Saucedo a penalty of:

- 1. A fine in the amount of two thousand and five hundred dollars (\$2,500.00). The fine is to be paid on or before April 18, 2018, in accordance with 15.2.3.8(B)(3)(l). Failure to pay the fine within the time prescribed may result in immediate suspension.
- 2. A 6 month suspension of all NMRC licenses February 24, 2018, through August 24, 2018, inclusive. (retroactive from the summary suspension issued on February 24, 2018.)

During said time of applicable suspension Jesus Alvarez is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, in accordance with 15.2.1.9 (C)(21). Additionally, effective upon applicable suspension dates, all horses owned or under the care of Jesus Alvarez are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained by or in the care and custody of <u>Jesus Alvarez</u> must done in accordance with <u>15.2.6.9A(12)(a)(b) Medication and</u> Prohibited Substances and 15.2.1.9(B)(8)(b) DUE PROCESS AND DISCIPLINARY ACTION.
