This win is the first step to getting this law passed. He is requesting support from NMRC of this bill as well. Mary Barber added that NMHBA is in full support of this bill. Jeff True reported that he believes that this a very important bill for the NM industry. Chairman Bregman asked Jeff True if there has been discussion regarding distribution of these funds. Jeff True reported that there has been discussion/negotiations. He deferred to State Representative Candy Ezzell. State Representative Candy Ezzell stated that the amendment has been drafted, approved and is on its way to the committee. Whenever she receives the amendment she will forward it to NMHA, NMHBA and NMRC. She also requests the support of NMRC for this very important part of legislation. Chairman thanked State Representative Candy Ezzell for all her hard work and for keeping an eye out for the industry up in Santa Fe. Chairman recalled hearing Jeff True referring to "near universal support" and asked if there is any stake holder or entity that is NOT in support of this bill. Jeff True responded that reference is made to structural detail of the bill. All the entities in the state have expressed their support of the bill. There were different ideas of	No Action taken.

Mr. Erhard responded that this has nothing to do with the lawsuit. Chairman Bregman agreed and further stated it is wonderful to see such a collaboration of all the stakeholders and was just wondering if the same consideration was given before the horsemen decided to sue the commission. Was there any discussion about the issues and problems prior to filing a lawsuit? Mr. Erhard responded that he has attempted to reach out to the Commission since he has come onto the board of NMHA, however the NMRC has been non-responsive and felt like there was no further choice but to file a lawsuit. We can expect the Amendment right after this meeting according to State Representative Candy Ezzell.  Jeff True reported that the amendment will change the basis of the distribution.
