The original lab report indicated a finding of Dexamethasone confirmed in the blood (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer, and declined.

#### No evidence was presented to disprove the findings of the NMRC.

Split sample rights as provided in <u>15.2.6.10 (D) NMAC</u>, were afforded to the trainer and owner, and declined. <u>Martin Orona Sr.</u> is the trainer of record for the horse "Apollitical Daizies"

### No evidence was presented to disprove the findings of the NMRC.

Jockey, <u>Luis A. Negron</u>, having appeared in front of the Board of Stewards at Zia Park Racetrack <u>on October 12, 2021</u>, for careless riding during the running of the <u>7th race on October 11, 2021</u>, while <u>aboard #7 "Bully Baby" which resulted in his mount being disqualified from 2nd place to 3rd place</u>. (Nearing the quarter pole, allowed his mount to drift in and make contact with #4 Ize A Crafty Gal causing that rival to steady.)

For this <u>rule violation</u>, the Board of Stewards assesses <u>Luis A. Negron</u> a fine of <u>\$250.00(Two Hundred and Fifty Dollars. This Fine Must be paid by November 12, 2021.</u>
