		Hoping to "crack" the \$5 million mark in pari-mutuel handle.  Executive Director Trejo acknowledged Amber Trujillo for doing a job well done (with the audit being reported last month).  Executive Director Trejo reported they are headed to SunRay Park for inspection before the start of the race meet either on April 5 or 6. He predicts it will be in tiptop-shape as Mr. Lonnie Barber always had the facility ready.  Executive Director Trejo reported a digital tattoo training was held at Sunland Park. He was pleased with the turn out and it went well.  Commissioners and Executive Director Trejo will be headed to Lexington, Kentucky in mid-April for the annual ARCI meeting to meet with the Federal Government, again. Although HISA is rolling forward, it is Executive Director Trejo's gut feeling the testing portion will not be in place by July 1. There is still a lot of work to get done.  Executive Director Trejo applauded the OOCT that occurred this last month at Sunland Park. 		comparison to other states in the nation. Executive Director Trejo responded NM is in the lead and in fact, the Federal Government mentioned that NM should be the "spokesperson" for HISA. If other states would do what New Mexico has been doing for testing, the racing industry might not be in the place it is with the Federal Government coming and taking over the regulation of horseracing. Chief Investigator Leasa Johnson will be in NY doing a presentation this upcoming week specifically regarding our OOCT. Commissioner Smith said pertaining to HISA all the paperwork he has read lately advises there is going to be some money due from somebody May 1, 2022, to pay for the new program. He understands we don't know the exact figure yet but asked Executive Director Trejo to opine what that number will be. Executive Director Trejo replied the only numbers he's heard of are that NM's costs, based on purse structure and number of starts of TBs in NM, is going to cost the NM Commission \$31,600 per million dollars that the program spends. To put that into perspective, if the program is going to cost \$60 million dollars nationwide it will cost the NM racing industry about 1.8 million to pay for TBs ONLY. 8. Unfinished/New Business and/or Action Items			
A. Approval of Statewide Retro Purse Policy Change	24:06 – 34:12	Executive Director Trejo presented the Retro Purse Policy that is "archaic". He referenced the old Retro Purse Payment Policy from 2006 and a new, revised one. Executive Director Trejo pointed out two matters: this policy should be specific to say "overnight purse money"; and he thinks there should be some accountability built in where the old policy had some percentages built in by including a "target" for tracks, such as 10%, for the tracks to hit. If the track is over 10%, it must retro purse money as a means of "forcing" the tracks to try to distribute the money rather than "horde" it. Chairman Bregman asked Executive Director Trejo whether the specific suggested changes to the proposed Retro Purse Policy Change would mean that everywhere it says "purse estimates" it should precede the word "purse" with the phrase "overnight estimates." On point #4 of the policy, it states "Any purse money not distributed will be carried over to the next meet unless otherwise approved by the Commission." 		should factor in a percentage here and it should read something to the effects of: "any non-distributed purse money over 10% of the overnight purse structure shall be distributed in a retro unless otherwise approved by the Commission." Bottom line, Executive Director Trejo believes the Commission should have the final decision regarding retro purse policies given that statutorily the Commission has regulatory authority over purses. The Commission should have the flexibility whether to retro or not, depending on the circumstances.  Commissioner Buffington agreed with Executive Director Trejo there should be some amount of percentage there and stated, "nobody wants a retro" and the accountability by putting a percentage there (although he believes 10% is too high) he thinks the Commission ought to try to keep that percentage reasonable (not too high), continue to monitor it, and the tracks need to stay on top of it.	
		Commissioner Smith stated he believes 10% is a good number. However, he notes this year is different due to the impacts of the pandemic.  Chairman Bregman asked if more thought needs to go into this and if tabling this matter right now is necessary. Commissioner Buffington recommended bringing this matter back next

Mr. Boehm expressed concern what not having the export signal approved by the horsemen will mean for SunRay and purses for the meet. The track has made all changes requested by NMHA and are patiently waiting for resolution.  Chairman Bregman asked who SunRay is communicating with, and Mr. Boehm responded they have been told the local committee has advised them they are not permitted to have any communication with SunRay at this point.  Chairman Bregman confirmed how much purse money the individual horsemen are potentially losing pursuant to the State Board withholding the export signal for this race meet. Mr. Boehm replied that when looking at last year's numbers they are looking at approximately \$70k in additional purse money that went directly to the horsemen and purse structure. SunRay was hoping to have all this in place by January 2022 so it can begin getting on people's lists to be imported by them as early as March, no later than April. SunRay at this point is already behind that curve.	
		Commissioner Smith asked Mr. Boehm if the State Board's main problem is the maiden races' purse money. Mr. Boehm confirmed this is one of the issues. Mr. Boehm went on to say there seems to be 3 issues: purse structure; purse distribution; and a few races that they would like

		to be included. Mr. Boehm said they agreed to include those races in their extra races, so he feels this issue was addressed. As far as purse distribution, after discussions with the horsemen, SunRay did make some accommodations and thought the issue was resolved. It seems the main problem is the purse distribution at this point. It would be detrimental to SunRay to announce a decrease in the claim races to make up the money in the maiden races. Commissioner Smith confirmed with Executive Direct Trejo the purse structure is approved by the Commission and the NMHA has no say so in this matter. Further, this item has been approved by the NMRC since last month. Commissioner Smith further confirmed that over the years it was a courtesy for the Commission to allow the horsemen give their input on condition books, etc., even though their input is NOT required.	
		Chairman Bregman asked if Mr. Gary Mitchell, Attorney for NMHA, was on the virtual meeting and if he would like to address the Commission regarding the issue of the export signal. Mr. Mitchell was not present.  Commissioner Sanchez asked Executive Director Trejo what conditions go along with the export signal. Executive Director Trejo reported the export signal is a stand-alone item when it comes to Federal law. It is a very confusing
