The hearing was in regard to a summary suspension instated on June 16, 2021, for the detection of the Class 3 drug Clenbuterol: (quarter horse "Jr Little Regard") Penalty A drug, in sample #E436415.

In accordance with 15.2.1.9(B)(3)(a), the Board of Stewards hereby continue the summary suspension of Javier Roman Jr's trainers license until a disciplinary hearing can be held on July 17, 2021 at 9:00 at Ruidoso Racetrack.

In accordance with 15.2,1.9 (C)(21), Javier Roman Jr. is hereby excluded from all areas of the grounds under the jurisdiction of the NMSRC and all horses owned, trained, or under the care of Javier Roman Jr are denied further entry.
