RE: 2021-RUI-38 - Ruling Final Outcome 8/29/21

Trainer: Stephanie Esparza, (currently under summary suspension) was duly notified and appeared through her attorney Gene Chavez by telephone before the Board of Stewards on August 28, 2021. The hearing was regarding the confirmed positive of the Drug Class 1 Penalty Class A. drug Oxymorphone, found in test sample E412731 taken from the 1st place finisher, "Feisty Foxey", in the 10th race on June 11, 2021, at Ruidoso Downs Racetrack.

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to trainer and denied.

Dezmer J. Harres, is the owner of record for the horse "Feisty Foxey".

Aggravating Factor: Oxymorphone is a Zero tolerance drug in New Mexico.

Aggravating Factor: Class 1 Drugs are a Stimulant which has the HIGHEST potential to affect performance

For Stephanie Esparza's FIRST Class 1A medication violation in a LIFETIME the Board of Stewards hereby assess a penalty, issued in accordance with 15.2.6.9 (B)(1) Penalty Recommendations, as follows:

- 1. A 2-year suspension of all NMRC licenses (retroactive from summary suspension) July 16, 2021, through July 15, 2023 inclusive.
- 2. A (20,000.00) Twenty thousand dollar fine to be paid on or before September 29, 2021, in accordance with 15.2.3.8 (B)(3)(k). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

In addition, Stephanie Esparza has accumulated "0" points prior to this ruling and "6" point in connection with this ruling for a current total of "6" under the multiple medication violation point system. under the multiple medication violation point system, Stephanie Esparza is subject to an additional penalty of 30 days pursuant to section 15.2.6.9 (O)(7) of NMAC.

Additional Days July 16, 2023, thru August 15, 2023.

In accordance with 15.2.1.9 (C)(21), Stephanie Esparza is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Stephanie Esparza are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Stephanie Esparza must be done in accordance with 15.2.6.9A(12)(a)(b) Medication and Prohibited Substances,

<u>Security Staff: Alvin Isaiah Simpson</u>, having been duly notified and failed to appear his hearing was held in absentia before the Ruidoso Downs Board of Stewards on <u>August 29, 2021</u>, for failing to disclose criminal/arrest history on his licensing application.

For this violation, the Board of Stewards issue Alvin Isaiah Simpson a penalty of the following: A revocation of any/all New Mexico Racing Commission licenses, effective immediately August 29, 2021, and is referred to the New Mexico Racing Commission for their further review prior to any further application. During said time of suspension Alvin Isaiah Simpson is denied access to all grounds under the jurisdiction of the New Mexico Racing Commission in accordance with 15.2.1.9(C)(21)(a-c) NMAC.

Licensee is found to be in violation of:

16.47.1.8 (L)(1) GROUNDS FOR REFUSAL, DENIAL, SUSPENSION, OR REVOCATION OF A LICENSE.
