Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer and declined.

Trainer **Vaughn Long** having appeared before the Board of Stewards on May 1, 2022 and having waived his right to a ten day notice and a formal hearing concerning a security citation for abusive language towards a racing official (outrider) is found to be in violation of Commission rules.

For this rule violation, the Board of Stewards assessed Trainer **Vaughn Long** a penalty in the amount of **Two Hundred and Fifty Dollars (\$250.00)**. This fine is to be paid on or before **May 30, 2022** in accordance with 15.2.3.8(B)(3)(I) NMAC. Failure to pay the fine within the time prescribed may result in immediate suspension.

Licensee is found to be in violation of:
