

Trainer Candelario Villamar having been duly notified and having waved his 10 day notice and formal hearing before the Board of Stewards on May 8, 2022, for not having a current coggins for the horse "Indian Gambler" for the 5th race on May 8, 2022 at Sunray Park which resulted in a late scratch.

The Board of Stewards hereby assesses penalty as follows:

1.A fine of Two Hundred Dollars (\$200.00) which must be paid on or before June 7, 2022.

Licensee is found to be in violation of and this ruling is written in accordance with 15.2.5.11 (A)(12): It lacks sufficient official published workouts or race past performance(s); 15.2.1.9(B)(9)(b): Appeal Procedures; Which states "An appeal under this section must be filed not later than 10 days after the day of the ruling. If the deadline falls on a Sunday or a legal holiday, the period is extended to the next day that is not a Saturday, Sunday or legal holiday. The appeal must be received by noon at the main commission offices or with the Stewards who issued the ruling and must be accompanied by a fee in the amount of \$400.00 dollars. The fee must be in the form of a cashier's check or a money order. Last day to file is May 18th, 2022.
