Ruling:

Trainer, Jose A. Rosales having been duly notified, for a hearing scheduled for Saturday May 14, 2022 having a telephonic hearing before the Board of Stewards on May 14, 2022 regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC), for a confirmed positive blood sample for the drug, Dexamethasone (LOD) and Diclofenac (class 4 penalty C) found in test sample E464675 taken from the 7th place finisher "Seattle Cartel" following the 9th race, on October 23, 2021 at Downs at Albuquerque Race track, New Mexico.

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer and declined.

Mr. Jose A. Rosales is the trainer of record for the horse "Seattle Cartel."

For Jose A. Rosales, 2nd violation within a 365-day period for a class 4 penalty C drug violation, issued in accordance with 15.2.6.9 (B)(4), the Board of Stewards assess a penalty as follows:

The Board of Stewards hereby assess penalty as follows:

A (\$1500.00) One Thousand Five Hundred fine and suspended 30 calendar days (Sunday May 14, 2022 through Sunday June 13, 2022.)

Fine to be paid on or before June 13, 2022 in accordance with 15.2.3.8 (B) (3) (1) NMRC.

Failure to pay fine in prescribed time will result in an immediate suspension until paid in full.

In addition, Mr. Jose A. Rosales has accumulated "1 point" for 2nd violation in 365 days, (.05 Dexamethasone) (.05 Diclofenac) under the multiple medication violation point system. Per 15.2.6.9 (O)(7)

Ruling:

Jockey, **Luis Ramon Rodriguez**, having been summoned and having appeared before the Board of Stewards **on May 14, 2022**, for careless riding during the running of the **8th race on May 13, 2022 at Sunray Park Racetrack**, while aboard "**Autopilot**". Bore out under left handed whip bumping outside horse at the finish line).

For this violation, the Board of Stewards assessed **Luis Ramond Rodriguez** a fine \$200.00 (TWO HUNDRED DOLLARS). To be paid on or before June 13, 2022.

Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(a) NMAC: Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."


Seattle Cartel is disqualified from 7th place and as a result will be unplaced.


Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the owner and declined.







Jockey Luis Negron, having been properly noticed on May 3, 2022 and having failed to appear or respond is hereby issued the following penalties:

1. A \$200.00 dollar fine for failure to review films as directed by the stewards on April 24, 2022 & April 29, 2022.
2. A 7 calendar day suspension Starting May 23, 2022 through May 29, 2022 for careless riding during the running of the 8th race on April 23, 2022.
3. A \$250.00 fine for failure to fulfill riding engagements on April 30, 2022 & \$250.00 for May 1, 2022 for a total of \$500.00

15.2.3.8(B)(3)(I). Failure to pay the fine within the time prescribed may result in immediate suspension.

Licensee is found in violation of:






