Trainer: Dick Cappellucci having been duly notified, and appeared before the Board of Stewards on December 7, 2021, to waive his right to a hearing regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC), for a confirmed positive for the drug, Phenylbutazone (class 4 penalty C drug) found in test sample E482968 taken from the 1st place finisher "Iza Daddy" following the 5th race, on November 16, 2021, at Zia Park Race Track.

The original lab report indicated a finding of **Phenylbutazone confirmed** in the blood at 0.405 ug/ml exceeding the limit of 0.30 ug/ml (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer and owner, and declined.

Ray Owen is the owner of record for the horse "Iza Daddy"

#### No evidence was presented to disprove the findings of the NMRC.

For **Dick Cappellucci** 1st Class 4-C medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4), the Board of Stewards assess a penalty as follows:

- 1. A (\$1000.00) One Thousand dollar fine to paid on or before <u>January 7, 2022</u>, in accordance with <u>15.2.3.8 (B)(3)(I) NMAC</u>. Failure to pay fine in prescribed time will result in an immediate suspension.
- 2. In addition, Dick Cappellucci has accumulated "0" points prior to this ruling and "0.5" points in connection with this ruling for a current total of "0.5", under the multiple medication violation point system.

Trainer: Dick Cappellucci having been duly notified, and appeared before the Board of Stewards on December 7, 2021, to waive his right to a hearing regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC), for a confirmed positive for the drug, Phenylbutazone (class 4 penalty C drug) found in test sample E482981 taken from the 1st place finisher "Short Pockets" following the 10th race, on November 16, 2021, at Zia Park Race Track.

The original lab report indicated a finding of Phenylbutazone confirmed in the blood at 0.574 ug/ml exceeding the limit of 0.30 ug/ml (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer and owner, and declined.

#### No evidence was presented to disprove the findings of the NMRC.

For Dick Cappellucci 1st Class 4-C medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4), the Board of Stewards assess a penalty as follows:

- 1. A (\$1500.00) One Thousand Five Hundred dollar fine to be paid on or before January 7, 2022, in accordance with 15.2.3.8 (B)(3)(1) NMAC. Failure to pay fine in prescribed time will result in an immediate suspension.
- 2. A suspension of 15 days from December 15, 2021, thru December 30, 2021. During said time of applicable suspension Dick Cappellucci is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, in accordance with 15.2.1.9 (C) (21). Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Dick Cappellucci are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained by, owned by, or in the care and custody of Dick Cappellucci must be done in accordance with 15.2.6.9 A (12) NMAC: Procedures shall be established to ensure that a licensed trainer is not able to benefit financially during the period for which the individual has been suspended.
- 3. In addition, Dick Cappellucci has accumulated "0.5" points prior to this ruling and "0.5" points in connection with this ruling for a current total of "1.0", under the multiple medication violation point system.

Owner Gabrriel R. Grado was duly notified and failed to appear so the hearing was held in absentia before the Board of Stewards on December 13, 2021. The hearing was regarding the confirmed positive of the Drug Class 3 Penalty Class A (Quarter Horses), Controlled Substance, Clenbuterol, found in the urine, test sample E482211 taken from the horse "Code Talker Eleven", who competed in the 4th race on August 29th, 2021, at Ruidoso Downs Racetrack.

Split sample rights were provided per 15.2.6.10 (D) NMAC, and confirmed by Kenneth L. Maddy Equine Laboratory. 15.2.6.9(C)(4) There is no permissible concentration of Clenbuterol that is allowed to appear in any official sample.

Mr. Manuel A. Vega is the trainer of record for the horse "Code Talker Eleven". Aggravating factor: The drug "Clenbuterol" is a controlled substance in New Mexico. Aggravating factor: The potential of this drug to influence a horse's performance.

For Mr. Gabriel R. Grado's First lifetime 3A medication violation issued in accordance with 15.2.6.9 (B)(1) Penalty Recommendations the Board of Stewards hereby assess a penalty as follows.

- 1. Pursuant to rule 15.2.6.9 (B)(1), the horse "Code Talker Eleven" is on the veterinarian's list for 180 days (December 13, 2021 to June 11, 2022) and must pass a commission-approved examination before becoming eligible to be entered.
- 2. The horse "Code Talker Eleven", is hereby disqualified from 3rd place and ordered unplaced from the 4th race on August 29, 2021, at Ruidoso Downs Racetrack, for all but pari-mutuel wagering. The purse redistribution is as follows
