For this violation, the Board of Stewards assessed Juan Carlos Rivas a fine of \$250.00 and suspended him for 7 days from the dates November 9, 2021 through November 15, 2021. Juan Carlos Rivas will be permitted to ride in designated race during the period of suspension. This fine is to be paid on or before December 10, 2021 in accordance with 15.2.3.8(B)(3)(l). Failure to pay this fine within the prescribed time shall result in immediate suspension.

Jockey Joel Leyva, having been summoned and appeared before the Board of Stewards on November 9, 2021, for excessive use of whip, while aboard "Last Call Senorita" in the 3d Race November 8, 2021 at Zia Park Racetrack, is found to be in violation of Commission rules.

For this violation, the Board of Stewards assessed, Joel Leyva, a fine in the amount of Five Hundred dollars, (\$500.00). This fine is to be paid on or before December 9, 2021 in accordance with 15.2.3.8 (B)(3)(I). Failure to pay the fine within the time prescribed shall result in immediate suspension. Licensee is found to be in violation of:
