Jockey Luis Guerrero currently under a summary suspension, since August 10th, 2022, had a summary suspension hearing scheduled for August 19th, 2022, at 9:00 a.m. in the office of the board of Stewards at the Downs at Albuquerque, (15.2.1.9 (B)(3)(b) Summary Suspension) Jockey Luis Guerrero appeared for his hearing regarding a security citation for Fighting in the stable area at the Downs at Albuquerque on August 7th, 2022. Jockey Luis Guerrero brought in 2 unlicensed personnel into the stable area resulting in an altercation that ended in serious injuries to multiple individuals.

In accordance with 15.2.1.9(B)(3)(a), the Board of Stewards hereby continue the summary suspension of all licenses belonging to Luis Guerrero pending the results of his disciplinary hearing.

In accordance with 15.2.1.9 (C)(21), Luis Guerrero is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC.

NMAC 16.47.1.8 (L) Grounds for disciplinary measures for a licensee, and refusal, denial, suspension, or revocation of a license:

(i) is a person whose conduct or reputation may adversely reflect on the honesty and integrity of horse racing or interfere with the orderly conduct of a race meeting; interfering with the orderly conduct of a race meeting shall include, but is not limited to, disruptive or intemperate behavior or behavior which exposes others to danger anywhere on the racetrack grounds; the fact that the race meet was not actually interrupted is not a defense to the imposition of discipline under this rule;
