Ruling:

Pari Mutuel Employee, Rachelle Jordan, having been duly notified and failed to appear before the Board of Stewards on August 3rd, 2022, at the Downs at Albuquerque Racetrack, for failure to disclose criminal/Arrest record on licensing application.

For this violation, the Board of Stewards have suspended Rachelle Jordan, until she can provide the Disposition of her Felony Charge.

Licensee is found to be in violation of:

16.47.1.8 (L)(1)(d) GROUNDS FOR DISCIPLINARY MEASURES The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has failed to disclose or falsely states any information required in the application.

16.47.1.8(L)(1)(F) CONDUCT: The commission may refuse to issue a license to an applicant, or may suspend or revoke a license issued, or order disciplinary measures, if the applicant has been found to have made false or misleading statements to the commission, stewards, or any racing official

This ruling is written in accordance with:
