For this violation, the Board of Stewards assessed, <u>Sergio Becerra Jr</u>, a fine in the amount of <u>One Thousand dollars</u>, (\$1,000.00). This fine is to be paid on or before <u>September 21, 2022</u> in accordance with <u>15.2.3.8 (B)(3)(l)</u>. Failure to pay the fine within the time prescribed shall result in immediate suspension.

#### Licensee is found to be in violation of:
