Trainer: Aurelio Valdez, currently under a summary suspension, since September 2, 2022, had a summary suspension hearing scheduled for September 10, 2022 at 8:30 a.m. in the office of the board of Stewards at the Downs at Albuquerque Racetrack, (15.2.1.9 (B)(3)(b) Summary Suspension) Aurelio Valdez appeared for the summary suspension hearing in regard to multiple drug violation on August 13th, 2022: Reining Pesos (Race2); Oh Gollie (Race 5); TobleRonne (Race 6), Jes Charge N Go (Race 7); Mr. Racy Perry (Race 10) all came back for the drug Guanabenz, a class 3 penalty B drug.

In accordance with 15.2.1.9(B)(3)(a), the Board of Stewards hereby continue the summary suspension of all licenses belonging to Aurelio Valdez pending the results of his split samples and disciplinary hearing.

In accordance with 15.2.1.9 (C)(21), Aurelio Valdez is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Aurelio Valdez are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Aurelio Valdez must be done in accordance with 15.2.6.9A(12)(a)(b) Medication and Prohibited Substances, and 15.2.1.9(B)(8)(b) DUE PROCESS AND DISCIPLINARY ACTION.
