Trainer, **Gary Cross** appeared before the Board of Stewards on September 14, 2022, regarding an Affidavit from Industrial Laboratories, the official testing laboratory for the NMRC, for a medication overage for the medication Furosemide confirmed in blood at 100 ng/ml (class 4 penalty C drug) found in test sample E465188. The sample E465188 was taken from the 1st place finisher "Ar Ya Weegee" following the 4th race, on August 24, 2022, at the DAA Racetrack. The horse "Ar Ya Weegee" finished 1st in the 4th race and as entered to run without the medication Furosemide. Trainer, **Gary Cross**, having been duly notified waived his right to a formal hearing before the DDA Board of Stewards.

Trainer, **Gary Cross** also represented **Maurenia Cross** the owner of record for the horse "Ar YaWeegee" at the time of the violation.

Trainer, **Gary Cross** is hereby fined \$250.00 (Two hundred and fifty dollars) for this violation in accordance with 15.2.6.9(B)(4) Penalty recommendations/. Fine is due to be paid by October 14, 2022.
