RE: 2020-RUI-46 - Modified Penalty
Kalie Hudson having been duly notified appeared telephonically before the Zia Park Board of Stewards, October 16, 2022, for her final hearing on the Summary Suspension from July 13, 2020. (2020-RUI-46)

September 23rd, 2022, Ms. Hudson was escorted to the Stewards office at the Downs of Albuquerque for working in a restricted area (the barn area) while currently suspended by the Ruidoso Downs Board of Stewards. Ms. Hudson has seven drug related rulings in the state of New Mexico and two in the state of Arizona. Further the two related rulings in the state of Arizona were in 2021 and 2022 during the time Ms. Hudson was already suspended in New Mexico for testing positive for Amphetamine at Ruidoso Downs July 13, 2022.

The suspension ruling (2020-RUI-46) for Kalie S. Hudson is hereby extended for a total of 5 years with the first date of suspension being July 13, 2020 and ending July 12, 2025.

Reinstatement is contingent upon:

1. Kalie Hudson is required to provide a Certificate of Completion from an Accredited Drug Rehabilitation Program
2. Ms. Hudson providing a negative biological sample (including but not limited to blood, hair, urine, and/or saliva)
3. Ms. Hudson must appear before the New Mexico Racing Commission for approval prior to reapplying for her license.

During the term of this suspension Kalie Hudson is denied access to All Facilities under the jurisdiction of the New Mexico Racing Commission.

Licensee is found in violation of:

16.47.1.17 B. Prohibited actions All licensees shall be deemed to be exercising the privileges of their license, and to be subject to the requirements of these rules, when engaged in activities that could affect the outcome of a race or diminish the conditions of safety or decorum required in restricted areas.

16.47.1.17 C. Restricted activities (7) presently has drugs (controlled substances) or alcohol in his/her body. With regard to alcohol, the results of a test showing a reading of more than five hundredths percent of alcohol in the blood, urine, saliva or other bodily fluids of licensees in non-safety sensitive positions shall be the criterion for a finding of alcohol present in the body. With regard to other controlled substances, presence of the drug in any quantity measured by the testing instrument establishes the presence of the drug for purposes of this paragraph. Licensees in safety sensitive positions, jockeys, starters, assistant starters, exercise riders, pony persons, ambulance personnel, and outriders are in violation of this rule if they have any measurable level of alcohol.


