Trainer, Wesley Giles having been duly notified, appeared before the Downs at Albuquerque Board of Stewards on September 10, 2022. Mr Giles waived his 10 day notice and disciplinary hearing, regarding an Affidavit from Industrial Laboratories (The official testing laboratory for the NMRC), a confirmed positive for the drug, Flunixin (class 4 penalty C drug) in test sample E507088 taken from the 1st place finisher "Fanncee" following the 9th race, on June 25th, 2022 at the Ruidoso Downs Racetrack.

The original lab report indicated a finding of Flunixin confirmed in the blood at 10.9 ng/ml exceeding the threshold of 5 ng/ml (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer and owner and confirmed by Texas A&M Laboratories.

MJ Farms (Mac Murray et al) is the owner of record for the horse "Fanncee."

For Wesley Giles 1st Class 4-C medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4), the Board of Stewards assess a penalty as follows:

1. A (\$1,000.00) One Thousand dollar fine to paid on or before October 10th, 2022, in accordance with 15.2.3.8 (B)(3)(I) NMAC. Failure to pay fine in prescribed time will result in an immediate suspension. 2. In addition, Wesley Giles has accumulated "0.5" points prior to this ruling and "0.5" points in connection with this ruling for a current total of "0.5", under the multiple medication violation point system.

Owner, **Mac Murray** having been duly notified and represented by his trainer Wesley Giles before the Downs at Albuquerque Board of Stewards on September 10, 2022, regarding an Affidavit from Industrial Laboratories, the official testing laboratory for the NMRC, for a confirmed positive for the drug Flunixin (class 4 penalty C drug) found in test sample E507088 taken from the 1st place finisher "Fanncee" following the 9th race, on June 25th, 2022, at the Ruidoso Downs Racetrack.

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded as the trainer and owner and were confirmed by Texas A&M Laboratories

Wesley Giles was the trainer of record for the horse "Fanncee" at the time of the violation.

In accordance with 15.2.6.9(B)(4) PENALTY RECOMMENDATIONS, this is Owner **Mac Murray** first Class 4C medication violation in a 365-day period. The Board of Stewards hereby assess penalty as follows:

1. The horse "Fanncee" is hereby disqualified from 1st place and ordered unplaced from the 9th race on June 25th, 2022, at Ruidoso Downs Racetrack for all but pari-mutuel wagering.
