Jockey <u>Oscar Ceballos</u>, having been summoned and appeared before the Board of Stewards on <u>August 7</u> 2022 for <u>excessive use of whip</u>, while aboard "<u>Golden Band"</u> in the <u>5th Race August 6, 2022</u> at Ruidoso Downs Racetrack, is found to be in violation of Commission rules.

For this violation, the Board of Stewards assessed a fine in the amount of <u>Five Hundred Dollars</u>, (\$500.00). This fine is to be paid on or before <u>September 6, 2022</u> in accordance with <u>15.2.3.8 (B)(3)(I)</u>. Failure to pay the fine within the time prescribed shall result in immediate suspension.

Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.
