Trainer Dick Cappellucci having been duly notified and waived his 10-day notice and formal hearing telephonically before the Board of Stewards on October 18, 2022, for failing to have the correct horse "IMAMONEYMAKER" in the paddock for the 5TH race on October 18, 2022, at ZIA Park Racetrack which resulted in a late scratch.

The Board of Stewards hereby assess penalty as follows:

1.A fine of Five Hundred Dollars (\$500.00) which must be paid on or before November 18, 2022.

Licensee is found to be in violation of and this ruling is written in accordance with 15.2.5.11 B. Identification: (1) Each horse must be properly identified prior to its participation in an official timed workout.

15.2.3.8 F(1) (2) F. Horse identifier: (1) General authority: The horse identifier shall: when required, ensure the safekeeping of digital or paper registration certificates and racing permits for horses stabled or racing on association grounds; inspect documents of ownership, eligibility, registration or breeding necessary to ensure the proper identification of each horse scheduled to compete at a race meeting; examine every starter in the paddock for sex, color, markings lip tattoo or microchip (ISO11784), freeze brand or other approved method of positive identification, for comparison with its registration certificate to verify the horse's identity; supervise the tattooing, micro chipping, freeze branding or other approved method of positive identification, for identification of any horse located on association grounds. Positive identification may include verification that the breed registration certificate has been submitted for correction or verification that the tattooing process has been initiated.

(2) Report violations: The horse identifier shall report to the stewards any horse not properly identified or whose registration certificate is not in conformity with these rules.

Jockey **Cesar T Moreno** having appeared telephonically before the Board of Stewards and waiving his 10-day notice and formal hearing on October 22, 2022, for failure to honor or be excused from his riding engagement on Saturday, October 22, 2022, in the 2nd race, (#4 SEND ME RUNNIN).

Cesar T Moreno failed to notify stewards that he would not ride which resulted in a late Jockey change.

For this violation, the Board or Stewards assessed, **Cesar T Moreno** a fine in the amount of Two Hundred and Fifty dollars, \$250.00. The fine is to be paid on or before November 21st, 2022, in accordance with 15.2.3.8 (B) (3) (1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

Jockeys shall report their engagements and any overweight to the clerk of scales. Jockeys shall not leave the jockeys' quarters, except to ride in scheduled races, until all their riding engagements of the day have been fulfilled except as approved by the stewards (3) Except as otherwise provided by this subsection, a jockey engaged for a certain race or for a specified time may not fail or refuse to abide by the engagement agreement, unless excused by the stewards. Failure to fulfill riding engagements may result in disciplinary action.

Ruling:

Jockey <u>Kevin Enriquez-Arenivas</u>, having been summoned and represent by Angel Emmanuel Marquez before the Board of Stewards on <u>October 23, 2022</u>, for <u>excessive use of whip</u>, (Fifth violation) while aboard "Volcom One" in the <u>11th Race October 22, 2022</u>, at ZIA Park, is found to be in violation of Commission rules.

For this violation, the Board of Stewards suspended <u>Kevin Enriquez-Arenivas</u> 14 calendar days from October 24, 2022, through November 6, 2022. and a (one thousand dollar) \$1000.00 fine. During the time of suspension Kevin Enriquez-Arenivas will not be permitted to ride in designated races.

Licensee is found to be in violation of:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.
