Trainer, Juan Carlos Gonzalez is hereby summarily suspended, effective immediately, October 7, 2022, pending the outcome of his summary suspension hearing scheduled for October 16,2022 at 9: 00 a.m. in the office of the board of Stewards at ZIA PARK Racetrack (3901 WEST MILEN DRIVE HOBBS, NM 88240.), per 15.2.1.9 (B)(3)(b) Summary Suspension. The summary suspension is regarding the confirmed positive of the Class 3 penalty A drug, Clenbuterol, found in the blood in test sample E556171 taken from the Quarter Horse "Restrictions", who finished in 1st place in the 8th race (La Fiesta Futurity) on September 25, 2022, at (Downs of Albuquerque Racetrack).

There is no permissible concentration of Clenbuterol allowed to appear in any official sample.

In accordance with 15.2.1.9 (C)(21), Juan Carlos Gonzalez t is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Juan Carlos Gonzalez are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). Mr. Dominguez acted as the interpreter for Mr. Aldrete. Hector Aldrete was the rider of the horse, "Starlite Eagle" in Race 5 on Sunday, September 18, 2022, at The Downs of Albuquerque. Mr. Aldrete failed to ride the horse out, standing up approximately 1/16th of a mile before the finish. After Mr. Aldrete stopped riding and stood up, the horse "Starlite Eagle" went from 3rd place to finish in 6th place.

The Zia Park Board of Stewards hereby fine Hector Aldrete \$2500. Dollars (Twenty-five Hundred Dollars) and suspend Mr. Aldrete's Jockey license for 30 calendar days (Thirty Days) beginning October 23rd, 2022, through November 22nd, 2022, for failure to ride out his mount his mount "Starlite Eagle" Race 5 on Sunday, September 18, 2022, at The Downs of Albuquerque

A violation of the following NMAC rules.

15.2.5.13 E (5) Post to Finish

(5) Horses shall be ridden out: All horses shall be ridden out in every race. A jockey shall not ease up or coast to the finish, without adequate cause, even if the horse has no apparent chance to win prize money.

(o) has engaged in conduct unbecoming or detrimental to the best interests of racing.

15.2.1.9 DUE PROCESS AND DISCIPLINARY ACTION:(9) Appeals.

- (a) A person who has been aggrieved by a ruling of the stewards may appeal to the commission. A person who fails to file an appeal by the deadline and in the form required by this section waives the right to appeal the ruling.
- (b) An appeal under this section must be filed not later than 10 days after the date of the ruling. If the deadline falls on a Saturday, Sunday or legal holiday, the period is extended to include the next day that is not a Saturday, Sunday or legal holiday. The appeal must be received by noon, at the main commission
- offices or with the stewards who issued the ruling and must be accompanied by a fee in the amount of \$400. The fee must be in the form of a money order, cashier's check or a corporate check.
- (c) The commission may fine a license holder in the amount up to \$2,500 after considering an appeal if based on the evidence the appeal is frivolous, unreasonable or unnecessary or determined to be an abuse of process or malicious. Failure of an appealing party to appear at a noticed hearing or withdraw their appeal without providing five business days' notice prior to the hearing date may result in the non-appearing appealing party being fined up to \$1,000.
- (d) An appeal must be in writing on a form prescribed by the commission. The appeal must include the name, address, telephone number and signature of the person making the appeal; and a statement of the basis for the appeal.
- (e) On notification by the commission that an appeal has been filed, the stewards shall forward to the commission the record of the proceeding on which the appeal is based, and a statement of the reasons for their rulings.
- (f) If a person against whom a fine has been assessed files an appeal of the ruling that assesses the fine, the person shall pay the fine in accordance with these rules.
