Mr. Starr is ineligible for licensing at this time due to the following violations. Mr. Star will be eligible to apply for an NMRC after 90 days (April 7th, 2023.)

December 13, 2022, Security Officer license was revoked at that time. Mr. Starr was informed at that time he could not work nor be present in a restricted area at any licensed racetrack under the jurisdiction of the NMRC.

Mr. Starr, was removed from the Backside/Restricted are at Sunland Park Racetrack on January 01, 2023, by Investigator Liz Garcia. At that time investigator Garcia informed Mr. Starr, he was not allowed on the backside or in any restricted area without a valid license.

January 3, 2023, Mr. Starr was brought into the Sunland Park Board of Stewards' office. Mr. Starr admitted he was helping his uncle Stan Johnson. Since Mr. Johnson has another job off track. Mr. Starr was told if he was unlicensed that he could not be working in racing or in any restricted area of a track. Mr. Starr stated he was going to get a license as a groom for Nancy Summers.

January 6, 2023, the Board of Stewards at Sunland Park received information that Mr. Devyn was again reported to be present and working on the backside of Sunland Park by stewards Gary Terrien and Larry Fontenot. Security was summoned to escort Mr. Starr to the stewards' office. Mr. Starr stated he did not get his license on Tuesday because he did not have the \$30. Fee. When questioned by the stewards, Mr. Starr, admitted, yes, he does know unlicensed persons should not be in a restricted area at Sunland Park and yes, he was a security officer at DAA and knows the rules.

Jockey, <u>Alexis Centeno</u>, having been summoned and having appeared before the Board of Stewards on <u>January 3, 2023</u>, for careless riding during the running of the <u>8 race on January 1, 2023</u>, at <u>SUNLAND Park</u>, while aboard <u>"IZE A CRAFTY GIRL"</u>. Alexis Centeno veered sharply from the rail to the outside causing the rider of #1 to check and potentially costing him a place. For this violation, the Board of Stewards assessed <u>Alexis Centeno</u> a fine of (\$500.00) Five Hundred Dollars. This fine is to be paid on or before February 2, 2023, in accordance with 15.2.3.8(B)(3)(l). Failure to pay this fine within the prescribed time shall result in immediate suspension.

Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."
