Jockey, Jacob Enriquez, having been summoned and appeared before the Board of Stewards January 13, 2023, for Careless Riding during the running of the 5th Race on January 7, 2023, at Sunland Park while aboard "Wahine". Approximately 40 yards from leaving gate the horse veered out without jockey trying to correct his horse action and without regard to other participants. He was taken down from First place and placed 9th, in order of finish.

For this violation, the Sunland Park Board of Stewards has suspended Jacob Enriquez for 7 calendar days from January 15 through January 21, 2023. During the time of suspension will be allowed to ride in designated aces.

Having been duly notified, Trainer, Mr. Justin Evans appeared telephonically and was represented in person by Attorney, Cal Mundell. A formal hearing was held by the Sunland Park Board of Stewards, on January 11, 2023, at 9:00 am. This hearing was held to hear the facts involving 2 horses purchased at Delmar California horse sell in 2018. The two horses were tattooed under incorrect names; "Aim Happy" was tattooed as the horse "Spirita" and "Spirita" was tattooed as "Aim Happy." Mr. Evans was the trainer of record for both horses at the time the horses were tattooed.

This hearing was to determine whether Justin Evans had violated 15.2.5.12 (A)(4) Horse Ineligible, 15.2.6.1 1 .)(1) Trainer Responsibility, 16.47.1.8 GENERAL PROVISIONS, 16.47. I .8. T. Knowledge of Rules, 16.47.1.10 (C) (5) TRAINERS and whether a penalty or other disciplinary action should be imposed.

Aggravating factor: Mr. Evans was present at the sale in Delmar, California at the time the two horses were purchased. He assisted the Nichols' in purchasing a "Ghost Zapper Filly". He saw the horse at that time and should have verified the identity of the horses prior to their being tattooed.

Aggravating factor: Mr. Evans was the trainer of record, for both horses at the time they were tattooed.

In accordance with 15.2.6.9(B)(4) penalty recommendations, for these violations Mr. Evans is hereby fined \$15,000. (Fifteen thousand) dollars by the Sunland Park Board of Stewards.

15.2.6.11 TRAINER RESPONSIBILITY: The purpose of this subsection is to identify responsibilities of the trainer that pertain specifically to the health and wellbeing of horses in their care. A. The trainer is responsible for the condition of horses entered in an official workout or race and is responsible for the presence of any prohibited drug, medication or other substance, including permitted medication in excess of the maximum allowable level, in such horses. A positive test for a prohibited drug, medication or substance, including permitted medication in excess of the maximum allowable level, as reported by a commission approved laboratory, is prima facie evidence of a violation of this rule. In the absence of substantial evidence to the contrary, the trainer is responsible.

D. Furosemide: 15.2.6 NMAC 9 (1) Furosemide may be administered intravenously to a horse, which is entered to compete in a race. Except under the instructions of the official veterinarian for the purpose of removing a horse from the veterinarian's list or to facilitate the collection of a post-race urine sample, furosemide shall be permitted only after the trainer enters the horse on furosemide on the entry card and only after the official veterinarian has placed the horse on the furosemide list. In order for a horse to be placed on the furosemide list, the following process must be followed: (a) After the horse's licensed trainer and licensed veterinarian determine that it would be in the horse's best interests to race with furosemide the official veterinarian or their designee shall be notified using the prescribed form that the horse is to be put on the furosemide list. (b) The form must be received by the official veterinarian or their designee by the proper deadlines so as to ensure public notification. (c) A horse placed on the official furosemide list must remain on that list unless the licensed trainer and licensed veterinarian submit a written request to remove the horse from the list. The request must be made to the official veterinarian or their designee, on the proper form, no later than the time of entry. (d) After a horse has been removed from the furosemide list, the horse may not be placed back on the list for a period of 60 calendar days unless it is determined to be detrimental to the

welfare of the horse, in consultation with the official veterinarian. If a horse is removed from the official furosemide list a second time in a 365-day period, the horse may not be placed back on the list for a period of 90 calendar days. (e) Furosemide shall only be administered on association grounds. (f) Furosemide shall be the only authorized bleeder medication. (2) The use of furosemide shall be permitted under the following circumstances on association grounds where a detention barn is utilized: furosemide shall be administered by the official veterinarian, the racing veterinarian, or practicing veterinarian no less than four hours prior to post in which the horse is entered. A horse qualified for furosemide administration must be brought to the detention barn one hour prior to the four hour administration requirement specified above. After treatment, the horse shall be required by the commission to remain in the detention barn in the care, custody and control of its trainer or the trainer's designated representative under association or commission security supervision until called to the saddling paddock.
