Ruling:

Jockey, Cristian Reyes-Sotelo, having been summoned and appeared before the Board of Stewards on March 3, 2023, for carreless riding during the running of the 4th race on February 25, 2023 while aboard "Midnight Special B". Cristian Reyes-Sotelo allowed his mount to drifted out sharply across the racetrack, causing an accident in which the rider of #6 was dopped. Cristian Reyes-Sotelo's mount, "Midnight Special B" was disqualified from 2nd (second) place and placed last (9th).

For this violation, the Board of Stewards assessed Cristian Reyes-Sotelo a suspension of 15 calender days. First day of suspension will be March 11, 2023 thru March 25, 2023. During this time Jockey Cristian Reyes-Sotelo will not be allowed to run in designated rsces.

Licensee is found in violation of:

15.2.5.13(E)(2)(a) NMAC: Post to Finish Which states in pertinent part that "A jockey shall not ride carelessly or willfully so as to permit his/her mount to interfere with, impede or intimidate any other horse in the race."

15.2.5.13(E)(3)(a) NMAC: Which states in pertinent part that "When the way is clear in a race, a horse may be ridden to any part of the course, but if any horse swerves, or is ridden to either side, so as to interfere with, impede, or intimidate any other horse, it is a foul."

This ruling is written in accordance with:

16.47.1.12 G. (2) A jockey suspended for 10 days or less for a riding violation, unless otherwise specified in the ruling, may continue to exercise horses during the training hours and may fulfill riding engagements in designated races, as designated by the stewards at the beginning of the race meet. (3) The official ruling where designated races are permitted shall state: "The term of this suspension shall not prohibit participation in designated race days."
