Owner, Horalia Rodriguez (Alvarez) the owner of record for the horse "Just de Vine", having been duly notified appeared before the Sunland Park Board of Stewards (1200 Futurity Drive Sunland Park, New Mexico 88063) on March 3, 2023. Horoalia Rodriguez exercised her right to a formal hearing regarding a lab report from Industrial Laboratories (the Official testing laboratory for the NMRC) for positive test for the Levamisole confirmed in the blood (Class 3 penalty B) from test sample E562984, taken from the horse "Just de Vine", the 1st place finisher in the 2nd race on December 17, 2022, at Zia Park.

Aggravating Factors: 1.Failure to guard. 2. The allowable limit for Levamisole.

Mitigating Factors: None

Considering all Mitigating and Aggravating factors the Sunland Park Board of Stewards determined the following.

- 1. Trainer Hector Rodriguez Jacquez is hereby fined \$500.00 (Five hundred dollars). Fine to be paid on or before **April 3, 2023**, in accordance with 15.2.1.9 (B)(7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.
- 2. A suspension of 15 days. The term of this suspension will start March 4,2023 and ending March 18, 2023.
- 3. In addition, Hector Jacquez has accumulated "0.0" points prior to this ruling and "4" points in connection with this ruling for a current total of ".5", under the multiple medication violation point system. No additional days given.

For this violation, Owner, Horalia Rodriguez:

1. Disqualification.

The horse "Just de Vine" is disqualified from 1st place and Unplaced in the 2nd race December 17, 2022, at Zia Park.

2. The horse "Just de Vine" must pass a commission-approved examination before becoming eligible to be entered.

The summary suspension is regarding a medication violation on Friday, February 17th, at Sunland Park: "Jess One Hot Chick" Sample E585591 tested positive for the drug Albuterol a class 3 penalty A drug. An affidavit from Industrial Laboratories (the official laboratory for the NMAC.) on March 6, 2023, reported the presence of Albuterol confirmed in urinne

Trainer: Ramon Mendoza having been duly notified appeared telephonically before the Sunland Park Board of Stewards on March 11, 2023, and waived his right to a formal hearing, regarding a lab report from Industrial Laboratories (The official testing laboratory for the NMRC), for a confirmed positive for the drug, Phenylbutazone (class 4C penalty drug) found in test sample E585225 taken from the 2nd place finisher "Alamo Lake" following the 3rd race, on January 14, 2023.

The original lab report indicated a finding of Phenylbutazone at 3.94 ug/ml +/-0.04 ug/ml in the blood, the allowable limit for Phenylbutazone is 0.3 ug/ml in the blood for a 4-C violation (15.2.6.9 Attachment 2).

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded to the trainer, and declined by trainer.

Ramon Mendoza is the Trainer of record for horse "Alamo Lake" at the time of the violation.

This is Ramon Mendoza's first 4C-Major medication violation, in a 365-day period, issued in accordance with 15.2.6.9 (B)(4). The Board of Stewards assessed a penalty as follows:

Aggravating circumstances:

1. The allowable limit for Phenylbutazone is 0.3 ug/ml, the horse "Alamo Lake" tested positive at a level of 3.94 ug/ml, this is 13 times over the allowable limit.

Mitigating circumstances:

This is trainer Ramon Mendoza's first violation of this classification in 365 days.

For this violation Mr. Ramon Mendoza's is fined \$1,500.00 (fifteen-hundred dollars). In addition, Ramon Mendoza has accumulated "0" points prior to this ruling and "0.5" points in connection with this ruling for a current total of "0.5" under the multiple medication violation point system.
