A formal hearing was held on Thursday April 13, 2023, regarding a lab report from Industrial Laboratories (the Official testing laboratory for the NMRC) for a confirmed positive for the drug Albuterol (Class 3 penalty A) found in the urine for test sample E585591, obtained from the horse "Jess One Hot Chick" finished 2nd place in the 2nd race on February 17, 2023, at the Sunland Park Racetrack.

Aggravating Factors: Failure to guard.

Mitigating Factors: First medication violation in 365 days.

Split Sample rights were afforded to the trainer. Sergio Ibarra declined sending a split sample.

Sergio Ibarra is the trainer of record for "Jess One Hot Chick".

After hearing the facts of the case and testimony, and considering all Mitigating and Aggravating factors the Sunray Board of Stewards determined the following

1. Mr. Sergio Ibarra is hereby fined \$10,000.00 (Ten Thousand). Fine to be paid on or before May 14, 2023, in accordance with 15.2.1.9 (B)(7)(f). Failure to pay the fine in the prescribed time shall result in an immediate suspension.

2. A suspension of one year. The term of this suspension will start retroactive from summary suspension dated March 7, 2023, through March 6, 2024.

3. In addition, Sergio Ibarra had accumulated "4" points prior to this ruling and "6" points in connection with this ruling for a current total of "10"- points, under the multiple medication violation point system. 120 additional days given. March 6th, 2024, thru July 4,2024.

Owner Sergio Ibarra, having been duly notified and appeared Via teams before the Sunray Park Racetrack Board of Stewards on April 13, 2023, regarding an Affidavit from Industrial Laboratories, the official testing laboratory for the NMRC, for a confirmed positive for the drug Albuterol (Class 3 penalty A drug) (Quarter Horse) found in blood test sample E585591 taken from the horse "Jess One Hot Chick", the 2nd place finisher in the 2nd race on February 17, 2023 at Sunland Park Racetrack.

Split sample rights as provided in 15.2.6.10 (D) NMAC, were afforded and Sergio Ibarra declined.

Sergio Ibarra was the trainer of record for the horse "Jess One Hot Chick" at the time of the violation.

For Sergio Ibarra's **first**-Class A medication violation in a 365 Days, the Board of Stewards hereby assess a penalty, issued in accordance with 15.2.6.9 (B)(1) Penalty Recommendations, as follows:

1. The horse "Jess One Hot Chick" is hereby disqualified from 2nd place and ordered unplaced from the 2nd race on February 17, 2023, at Sunland Park Racetrack for all but pari-mutuel wagering.

2. The horse "Jess One Hot Chick" must pass a commission approved examination and test clean in the urine on or after October 11,2023 before being eligible to enter.

3. The horse "Jess One Hot Chick" will be on the Veterinarians List for 180 days beginning April 14, 2023.
