Trainer Edwin A Martinez having been duly notified and having waived his 10-day notice and formal hearing before the Board of Stewards on April 22, 2023, failure to have flipping rig for the horse "Carson City Gambler" in the 10th race on April 21, 2023, and causing a late scratch at Sunray Racetrack.

The Board of Stewards hereby assesses penalty as follows:

1.A fine of Five Hundred Dollars (\$500.00) which must be paid on or before May 22, 2023.

Ruling:

Jockey **Luis R Rodriguez** having appeared before the Sunray Park Board of Stewards and waiving his 10-day notice and formal hearing on April 23, 2023, for failure to honor or be excused from his riding engagement on Saturday, April 22, 2023, in the 10th race, (#7 Auspice).

Luis R Rodriguez failed to notify stewards in a timely manner that he did not want to ride which resulted in a late scratch.

For this violation, the Board or Stewards assessed, **Luis R Rodriguez** a fine in the amount of Two Hundred and Fifty dollars, (\$250.00). The fine is to be paid on or before May 23, 2023, in accordance with 15.2.3.8 (B) (3) (1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13 (C)(1) (3) Jockey requirements: (1) Jockeys shall report to the jockeys' quarters at the time designated by the association. Jockeys shall report their engagements and any overweight to the clerk of scales. Jockeys shall not leave the jockeys' quarters, except to ride in scheduled races, until all their riding engagements of the day have been fulfilled except as approved by the stewards.

(3) Except as otherwise provided by this subsection, a jockey engaged for a certain race or for a specified time may not fail or refuse to abide by the engagement agreement, unless excused by the stewards. Failure to fulfill riding engagements may result in disciplinary action.
