Trainer Alfredo Gomez having been duly notified and having waived his 10-day notice and appeared by phone before the Sunray Park Board of Stewards on May 19, 2023, for scratching the horse "Quemandos Royal Moon" out of the 2nd Race claiming race because Owner did not want to run in the race, causing a late scratch at Sunray Racetrack.

(1) Any horse entered in a claiming race that is not present in the paddock at least 10 minutes to post will be scratched

16.47.1.10 TRAINERS: C. Other responsibility: (17) representing an owner in making entries and scratches and in all other matters pertaining to racing; horses entered as to eligibility and weight or other allowances claimed;

The Board of Stewards hereby assesses penalty as follows:

A fine of Five Hundred Dollars (\$500.00) which must be paid on or before June 18, 2023.

Licensee is found to be in violation of and this ruling is written in accordance with 15.2.1.9(B)(9)(b): Appeal Procedures, which states "An appeal under this section must be filed not later than 10 days after the day of the ruling. If the deadline falls on a Sunday or a legal holiday, the period is extended to the next day that is not a Saturday, Sunday, or legal holiday. The appeal must be received by noon at the main commission offices or with the Stewards who issued the ruling and must be accompanied by a fee in the amount of \$400.00 dollars. Ruling:

Trainer Eugene C. Garcia having been duly notified and having waved his 10-day notice and formal hearing telephonically before the Board of Stewards on May 19, 2023, for not having a current Coggins for the horse "Dontmesswiththelady" for the 9th race on May 19, 2023, at Sunray Park which resulted in a late scratch.

The Board of Stewards hereby assesses penalty as follows:

1. A fine of Five Hundred Dollars (\$500.00) which must be paid on or before June 18, 2023.

Licensee is found to be in violation of and this ruling is written in accordance with 15.2.5.12(A)(26) HORSES INELIGIBLE:

A. A horse shall be ineligible to start in a race when:

(26) there is no current negative test certificate for equine infectious anemia on file with the racing office, as required by the commission

Ruling:

Trainer Clifton Dennis appeared telephonically and waving his ten-day notice to a hearing before the Board of Stewards on May 21, 2023, for not having the correct horse, (Ax's Shore)in the paddock causing a late scratch for the 5th race, on May 6, 2023, at Sunray Part Racetrack. Licensee is found to be in violation of Commission rules.

For this rule violation, the Board of Stewards assessed a penalty in the amount of Five Hundred dollars (\$500.00). The fine is to be paid on or before June 21, 2023, in accordance with 15.2.3.8(B)(3) (I) NMAC.

Licensee is found to be in violation of the following rules:
