Trainer, Vilma De La Cruz having been duly notified, appeared before the Ruidoso Downs Board of Stewards for her summary suspension hearing in the office of the Board of Stewards at Ruidoso Downs Racetrack (26225 US Highway 70, Ruidoso Downs, New Mexico 88346) on Sunday, June 11, 2023, at 10:00 a.m., per 15.2.1.9 (B)(3)(b) Summary Suspension. This summary suspension hearing was regarding Vilma De La Cruz being found in possession of a hypodermic needle and syringe, containing an unknown injectable substance, in her vehicle in the barn area on June 3, 2023. Due to the laboratory results of the unknown injectable substance not being available at this time, and after deliberation, taking into consideration all information presented, the Ruidoso Downs Board of Stewards hereby continue Mrs. De La Cruz's summary suspension until the completion of her final disciplinary hearing.

In accordance with 15.2.1.9 (C)(21), Vilma De La Cruz is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC. Additionally, effective upon applicable suspension dates, all horses owned, trained, or under the care of Vilma De La Cruz are ineligible to be entered or start in any race in this jurisdiction, per 15.2.1.9 (C)(21)(c). All transfers and sales of horses trained, owned, or in the care and custody of Vilma De La Cruz must be done in accordance with 15.2.6.9a(12)(A)(B) Medication and Prohibited Substances.

NMAC 15.2.1.9(B)(3)(b) Proceedings Before the Stewards: Summary Suspension A licensee whose license has been summarily suspended is entitled to a hearing on the summary suspension not later than the 10th day after the license was summarily suspended. The licensee may waive their right to a hearing on the summary suspension within the 10-day limit.
