Trainer Osman Iturralde having been duly notified and having waived his right to a formal hearing before the Board of Stewards on July 14, 2023, for failure to have the horse "Parker Dam" treated with furosemide, resulting in a late scratch and pari-mutuel refund in the 11th race on July 9, 2023, at Ruidoso Downs Race Track.

For this rule violation, the Board of Stewards assessed Osman Iturralde a penalty in the amount of Two Hundred Fifty Dollars (\$250.00). The fine is to be paid on or before August 13, 2023, in accordance with 15.2.3.8(B)(3)(I) NMAC. Failure to pay the fine within the time prescribed will result in immediate suspension.

Licensee is found in violation of:

15.2.6.(D)(3) The use of furosemide shall be permitted under the following circumstances on association grounds where a detention barn is not utilized: furosemide shall be administered by the official veterinarian, the racing veterinarian, or practicing veterinarian no less than four hours prior to post in which a horse is entered; the horse must be logged in at the stable gate with time and location no less than one hour prior to administration; the furosemide dosage administered shall not exceed 500 milligrams nor be less than 150 milligrams; the trainer of the treated horse shall cause to be delivered to the official veterinarian or their designee no later than one hour prior to post time for the race for which the horse is entered the following information under oath on a form provided by the commission: the racetrack name, the date and time the furosemide was administered to the entered horse; the dosage amount of furosemide administered to the entered horse; the printed name and signature of the attending licensed veterinarian who administered the furosemide.

Jockey Luis Martinez, having been summoned and appeared before the Board of Stewards on July 15, 2023, for excessive use of whip, while aboard "Mr Perrisimo" in the 9th Race July 14, 2023, at Ruidoso Downs, is found to be in violation of Commission rules.

For this violation, the Board of Stewards assessed Jockey Luis Martinez, a fine in the amount of Five-Hundred Dollars. (\$500.00). This fine is to be paid on or before August 13, 2023, in accordance with 15.2.3.8 (B)(3)(1). Failure to pay the fine within the time prescribed shall result in immediate suspension.

Licensee is found to be in violation of:

15.2.5.13(E)(6)(A) Use of riding crops. Although the use of a riding crop is not required, any jockey who uses a riding crop during a race shall do so only in a manner consistent with exerting his or her best efforts to win.

15.2.5.13(E)(6)(e) Use of riding crops. Indiscriminate use of the whip is prohibited including whipping a horse: on the head, flanks or on any other part of its body other than the shoulders or hind quarters except when necessary to control a horse; during the post parade or after the finish of the race except when necessary to control the horse; excessively or brutally causing welts or breaks in the skin; when the horse is clearly out of the race or has obtained its maximum placing; persistently even though the horse is showing no response under the riding crop; or striking another rider or horse.

Owner Oscar Rincon is hereby summarily suspended, effective immediately July 16, 2023, after he was involved in an unprovoked attack upon another licensee, behind the starting gate at Ruidoso Downs, during training hours on July 14, 2023. Mr. Rincon was admittedly the aggressor in the attack and told investigators the attack was in retaliation from a past "Drug Conspiracy" case, in which Mr. Rincon served five years in prison for being involved in a drug cartel ring. Mr. Rincon will remain suspended pending the outcome of his summary suspension hearing scheduled on July 28, 2023, at 9:00 A.M. in the offices of the Board of Stewards at Ruidoso Downs Racetrack (26225 US Highway 70, Ruidoso Downs, NM 88346) per 15.2.1.9 (B)(3)(b) (Summary Suspension). During said time of applicable suspension, Oscar Rincon is hereby excluded from all areas of the grounds under the jurisdiction of the NMRC, per 15.2.1.9 (C)(21) (a-b) Exclusion.

Jockey Gabriel Arredondo, having been duly notified, and waived his right to a 10-day notice and hearing and having appeared before the Board of Stewards on Sunday July 16, 2023, concerning failure to make his assigned weight on Friday July 16, 2023 at Ruidoso Downs Racetrack for the 2nd and 4th races, resulting in late jockey changes, and for the 8th race, resulting in a late scratch.

The Board of Stewards hereby assesses Gabriel Arredondo a penalty in the amount of Two Hundred Fifty Dollars (\$250.00). The fine is to be paid on or before August 15, 2023, in accordance with 15.2.3.8(B)(3)(1) NMAC. Failure to pay the fine within the time prescribed will result in immediate suspension.

C. Jockey Requirements:

(1) Jockeys shall report to the jockeys' quarters at the time designated by the association. Jockeys shall report their engagements and any overweight to the clerk of scales. Jockeys shall not leave the jockeys' quarters, except to ride in scheduled races, until all of their riding engagements of the day have been fulfilled except as approved by the stewards.

(11) A jockey's weight shall include their clothing, boots, saddle and its attachments and any other equipment except the whip, bridle, bit or reins, safety helmet, safety vest, blinkers, goggles and number cloth. Upon the stewards' approval, jockeys may be allowed up to three pounds more than published and announced weights to account for inclement weather clothing and equipment when weighing in.

(12) Five pounds is the limit of overweight any horse is permitted to carry.
